6. Opinion:



In addition, the incident must be caused by either non-combat activity of the Unites States Armed Forces or by negligent or wrongful acts of military members or civilian employees of the Armed Forces.

- b. There is insufficient evidence to suggest that this incident arose out of the negligence and/or wrongful acts of the United States Armed Forces.
- c. The SIGACT reports do not corroborate claimant's version of the events, so there is no evidence to suggest that U.S. Forces were responsible for claimant's damages. The claimant also submitted no additional evidence for reconsideration.
- 7. Recommended Action: This claim is not payable under the FCA for the above-mentioned reasons. Consequently, this claim of \$5,000 for reconsideration is denied.



a. In order to form a basis for a claim under the FCA, the incident in question must have arisen outside the Unites States. In addition, the incident must be caused by either noncombat activity of the Unites States Armed Forces or by negligent or wrongful acts of military members or civilian employees of the Armed Forces.

- b. There is insufficient evidence to suggest that this incident arose out of the negligence and/or wrongful acts of the United States Armed Forces. Based on the facts and circumstances, the SIGACT reports that U.S. forces did not kill claimant's son nor cause the damage to the vehicle.
- 7. <u>Recommended Action:</u> This claim is not payable under the FCA for the above-mentioned reasons. Consequently this claim for \$5,000 is denied.
