SUBJECT: Appointment as Investigating Officer

1. Pursuant to AR 15-6, paragraph 2-1, you are hereby appointed as an investigating officer to investigate the escalation of force incident involving members of SVC/4-1 FA and B/4-42 FA that resulted in the death of one local national on 10 January 2006.

 3. If it becomes evident that there is possible misconduct outside the scope of your investigation notify the appointing authority immediately. If during your investigation you become aware of information that needs command attention, immediately notify the appointing authority for guidance.

While on MSR Tampa 9th 10 JAN 06 [REDACTED] were searching a vehicle on the MSR. While searching a vehicle on the MSR our vehicle (H2-8) was the rear vehicle. We were pulling rear security as the two other vehicles on our patrol were searching a vehicle that was on the MSR Tampa, well after curfew hours. As we were pulling security 2 vehicles had arrived. The vehicles were approximately 25-50 meters away from our vehicle. Myself & Sgt [REDACTED] were outside of our vehicles & SSG [REDACTED] (who was conducting, right seat right) was trying to get out of the Humvee. I told the first truck to move forward to get searched along w/ Sgt [REDACTED] telling the first truck the same thing. We were both waving our flashlights. He moved up & the second vehicle started moving forward. As he started moving forward, I started yelling for him to stop, while signaling for him to halt w/ the halt sign (my thumb touching mid-joint of my ring finger & middle finger). At the same time I was flashing my surefire flashlight.

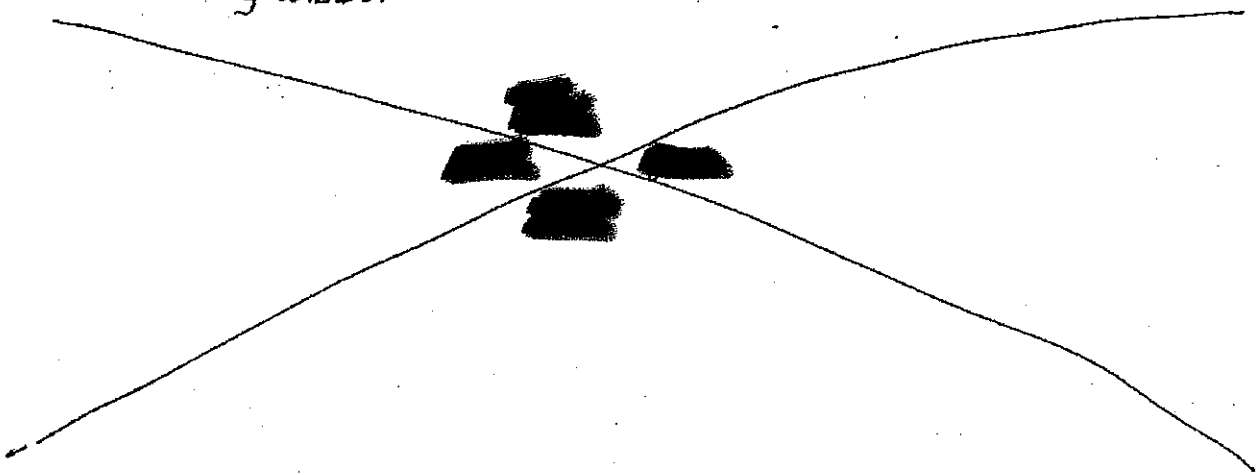

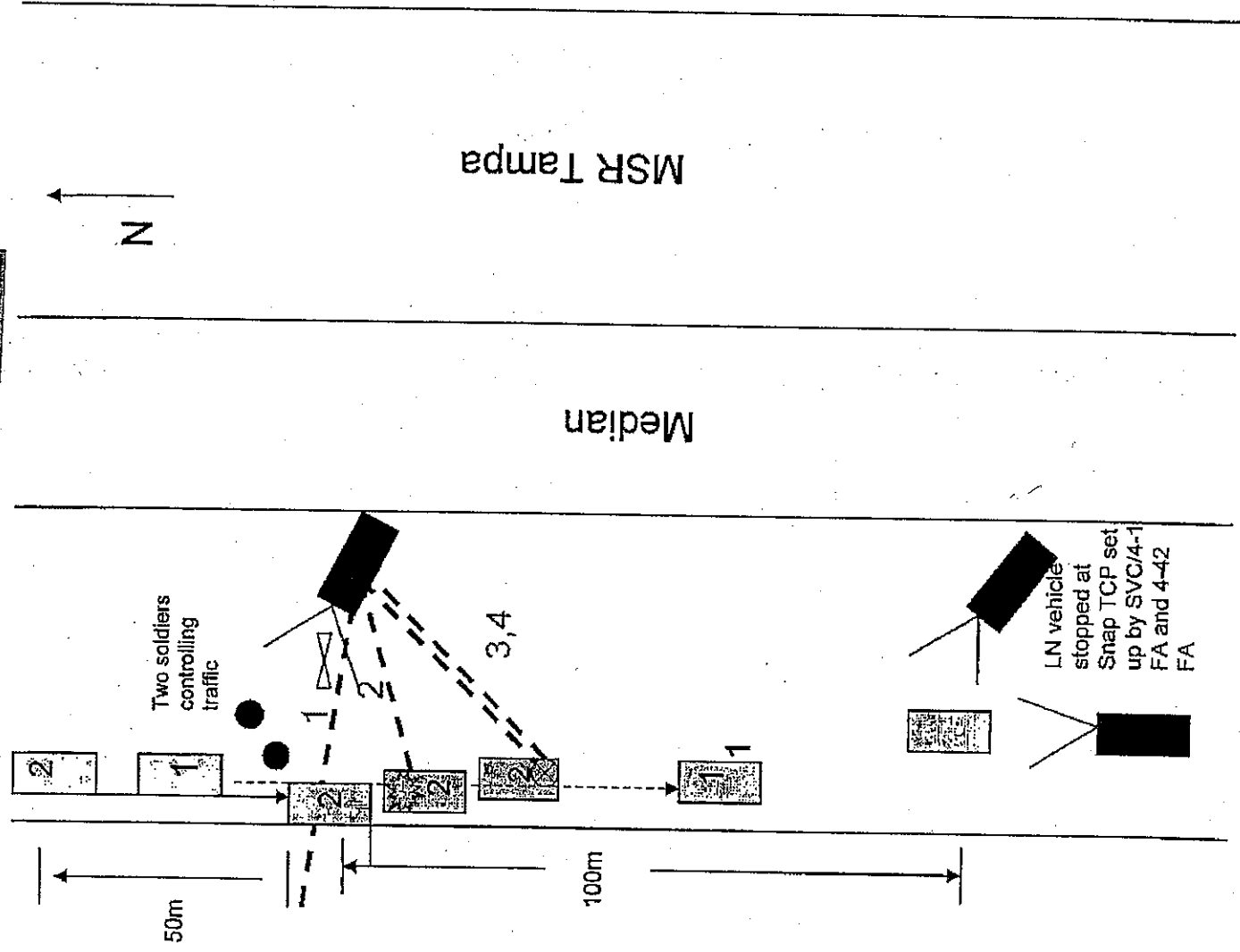

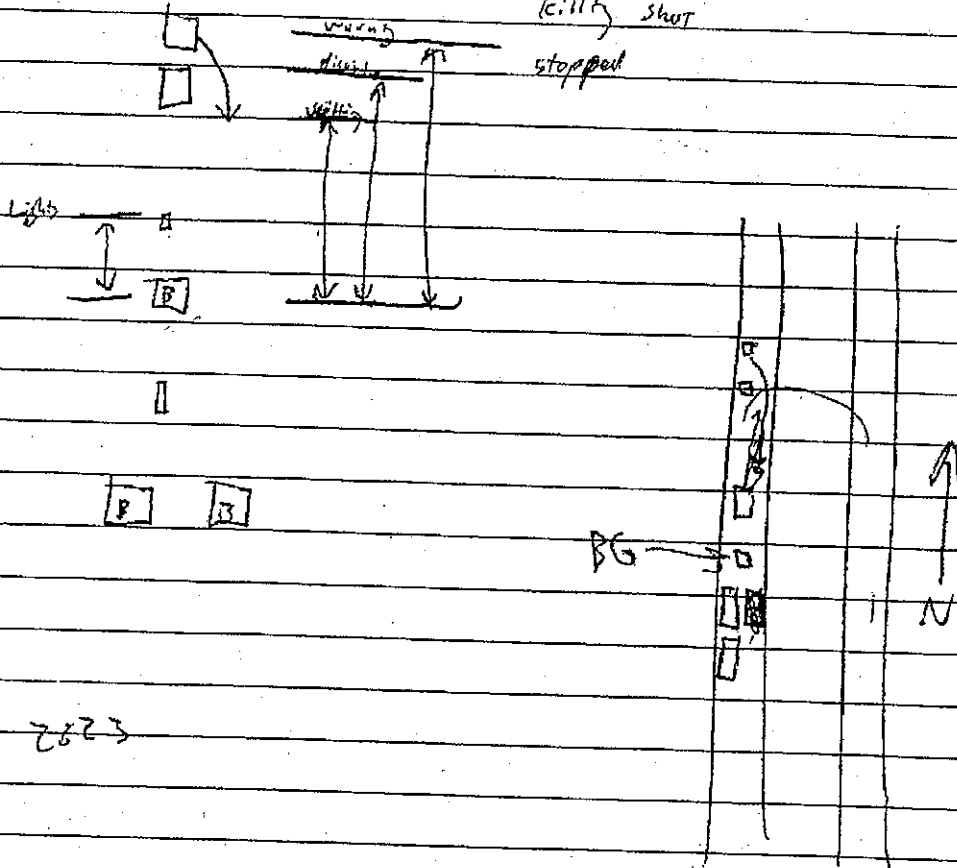
