AS SOON AS THE ROOUNDS IMPACTED THE WINDSHIELD THE VAN TURNED RIGHT (SOUTH) OFF THE ROAD INTO THE FIELD AND STOPPED ABOUT 50M TO MY SOUTH. THATS WHEN I NOTICED IT WAS A FAMILY OF ABOUT 8 MEN, WOMEN, CHILDREN. ABOUT 1 MINUTE LATER I HEARD 5 TO 6 ROOUNDS FIRED TOWARD OUR DIRECTION I SAW MURRELLE FLASHES ABOUT 400M TO OUR DIRECT FRONT NEXT TO A YELLOW BOX ON THE NORTH SIDE OF [REDACTED] THEN I LOOKED BACK AT THE VAN AND COULD SEE SOME PEOPLE MOVING AND SCREAMING. THATS WHEN THE CORPSMEN MOVED TO MY POSITION AND GOT WORD FROM LT. OWEN TO CHECK THE WOUNDED. AS SOON AS WE REACHED THE VAN I NOTICED 3 DEAD MALES. AT THE SAME TIME MARINES AND CORPSMEN FROM COMPANY 'C' WERE THERE HELPING WITH SECURITY AND AID. THE WOUNDED WERE BEING TREATED SO I WENT BACK TO MY TRUCK TO HELP SET UP OUR ROAD SIGNS AND L-WIRE TO BLOCK ALL TRAFFIC. 3 TO 5 MINUTES LATER THE IA SHOWED UP. A FEW MINUTES LATER 5 WOUNDED WERE LOADED INTO TRUCKS WITH THE SA AND BROUGHT TO ABU GHRAIB MEDICAL CENTER. THEN 3 TRUCKS OF IA'S CAME AND LOADED THE 3 DEAD AND TOWED THE VAN BACK TO THE IA STATION. THEN WE LOADED UP INTO OUR TRUCKS AND WENT BACK TO THE WEST GATE AT FOB ABU GHRAIB

I was driving for lead truck in Map 2's convoy. We were facing West on MSR [REDACTED] providing SUSEC (S52)(b)(1) security, when a van traveling about 70mph came at us from the front. I first saw the vehicle at about 175m away. As the van kept coming I saw a round hit the deck, follow by one to the engine. The van didn't change course and slow in speed. My gunner then open fire on the crew of the vehicle. The van then swirved off the road at about 50m from the truck. Marines checked for possible explosives then treated the wounded. At the same time I heard AK-47 fire, then saw IAs firing NW of this position. After this my truck went down the road west.

ON 20060316 AT APPROX. 1645 WHILE ON AN ESCORT MISSION IN THE CITY OF ABU GHRAIB, OUR CONVOY TURNED WEST ONTO [REDACTED] AND CAME TO A STOP SO THAT THE WRECKER WE WERE ESCORTING COULD RECOVER A 7-TON TRUCK THAT WAS STUCK. I WAS THE THIRD VEHICLE IN THE CONVOY AND APPROX. 150M BEHIND THE LEAD VEHICLE. MY VEHICLE IS A HIGH BACK AMBULANCE. I WAS SCANNING THE NORTHWEST SECTOR WITH BINOCULARS, AS I PULLED THE BINOCULARS DOWN I SAW A WHITE VAN TRAVELING AT A HIGH RATE OF SPEED (APPROX. 60 MPH) EASTBOUND ON [REDACTED] TOWARD THE LEAD VEHICLE OF THE CONVOY. AT THAT TIME THE VAN WAS APPROX. 200M AWAY FROM THE LEAD VEHICLE. I THEN SAW THE GUNNER IN THE LEAD VEHICLE PUT SOMETHING DOWN IN THE TURRET AND FIRE THE .50 CAL AT THE APPROACHING VAN. THE INITIAL SHOTS IMPACTED THE GROUND, THEN THE GRILL, THEN THE REARWINDSHIELD. THE VEHICLE DID NOT SLOW DOWN, BUT

WHILE THE VEHICLE WAS STILL ROLLING I ALSO HEARD A SMALLER CALIBER AUTOMATIC WEAPON FIRE ON THE VAN. THE VAN THEN CAME TO A STOP. DUE TO THE RECENT THREAT OF VBIED'S AND ACTUAL SUBIED ATTACKS, MY VEHICLE AND THE CORPSEMAN WAITED FOR THE SCENE TO BE SECURED, THEN MOVED IN TO RENDER AID. I ASSISTED THE CORPSEMAN WITH TREATMENT AND MEDICINE.

At about 1400 we got the word that we had a mission. The was to escort a recovery vehicle to C. Co. Pos to retrieve a 7 ton. we left the FOB at around 1500. It took us about to get to the recovery site. My vehicle was escorting the recovery vehicle, once we got there I moved my vehicle and the recovery veh. of the road toward the 7 ton. I then heard the so cal open up. After hearing the first round I looked towards the road and notice a minivan driving at a high rate toward the lead vehicle the vehicle then went off the road and was still rolling towards C. Co. marines. At that time one of C. Co. saw gunners fired a sweet at the vehicle. The vehicle finally came to a stop. No one went near the vehicle cause we thought it was a SVBIED. After about 10 mins pass I went with our Corporal to assist with the casualties of the minivan. When I got there I saw 3 dead males, 3 women that were injured along with 3 kids ranging in age 8 yrs to 16 yrs old.

Q. Who fired the shot at the minivan?

A. One of the Charlie Company saw gunners.

Q. Was there any other gunfire?

A. After the so cal fired I heard 4-5 rounds fire from an AK-47.

After the vehicle was disabled I saw and heard a muzzle flash and 4 to 6 rds fired. After the vehicle was disabled it rolled down the berm at 40 to 50 mph, so it was coming at a high speed. I couldn't see the van from the gunners seat. I first made visual contact with the van as it rolled down hill. The time was ground 1730-1800. I first made visual contact with the civilian van as it rolled down the berm.

Our convoy headed west on [REDACTED] and I saw the 7-ton to my left that was stuck. Our truck, which is the lead vehicle, stopped to assess where we could post our truck for security. Then we saw the main-conv coming toward us at approximately 65-70 mph. We had been warned of many SBIEDs by our command so we were very cautious. The gunner was wearing his head and I assumed he had the flag also. The vehicle did not stop and I heard a shot to the deck. The vehicle still did not stop and I then saw another shot hit near the grill. It still did not stop and that's when I heard the .50 cal firing off the vehicle. The vehicle veered off the side of the road & the Main-conv were rushing towards it. We set up a road block so no oncoming traffic could continue down the road. The 1st shot at the deck was probably at 250m. The second was at about 150m. The vehicle went off the road at about 50-75m away.

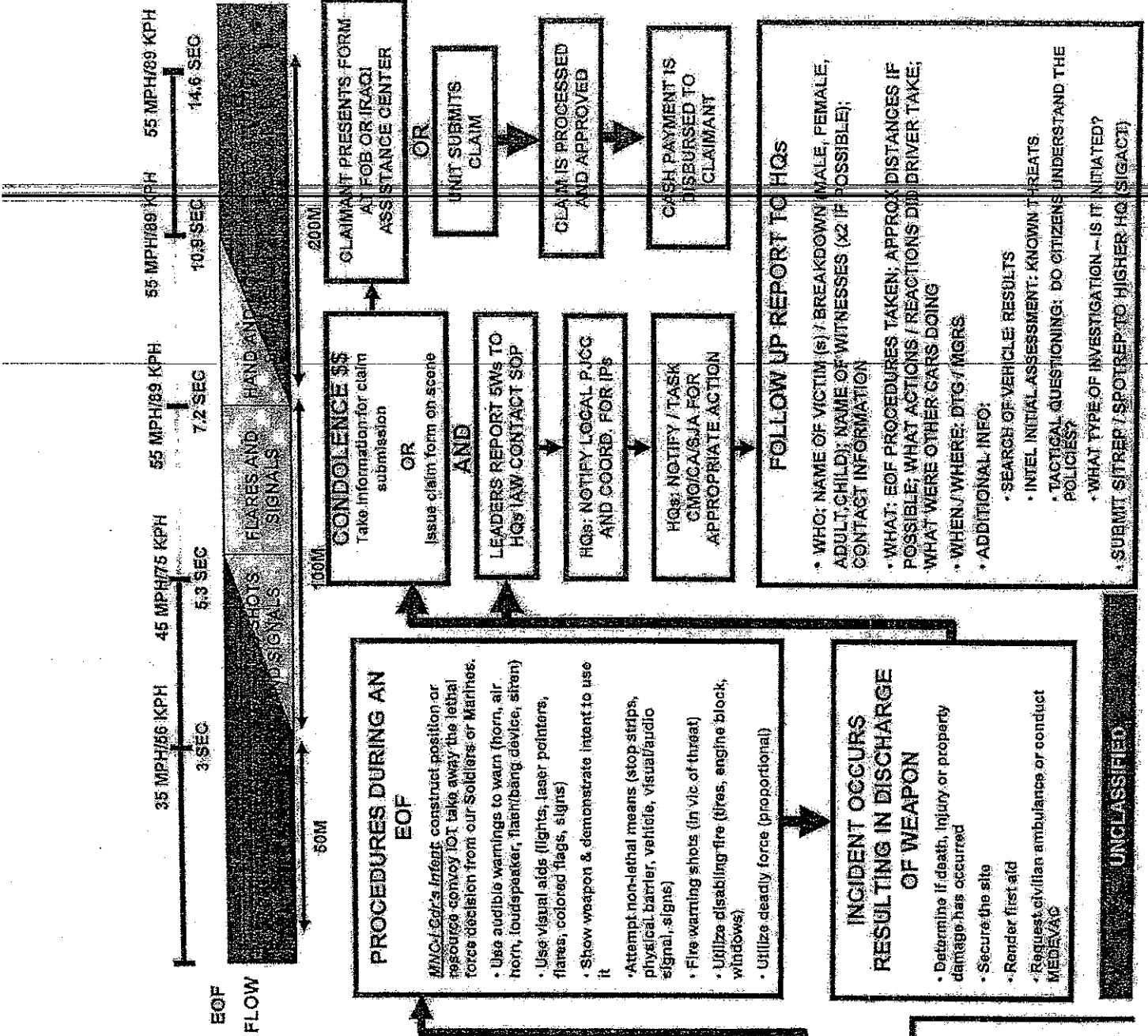
