

OPERATION DIRTY SOUTH SUMMARY

At approximately 312030MAY06, LONEWOLF SP FOB ISKANDARIYAH to insert VIPER vic OBJ HOUSTON IOT overwatch the OBJ. LONEWOLF was able to insert the VIPER without being compromised. LONEWOLF then went to a hide position a few kilometers northeast on RTE

██████████ From their insertion point, VIPER infiltrated north to a hide position approximately 400m east and 200m south of the objective. While at their hide position VIPER was concerned that Dogs in the area would compromise them, so they requested that DOG 6 move the target hit time forward. DOG 6 agreed and moved the hit time forward to 0130. S05055266(U)

Team DOG SP FOB ISKANDARIYAH at approximately 010040JUN06. Team DOG rallied just east of CP15, at this time four trucks from DOG's HQ broke off to the south to pick up IPs at MIPS. MIPS gave Team DOG one gun truck and four IP s. Once the IP s were picked up, Team DOG SP CP15 toward the objective area. At this time Team DOG did not have FM communication with LONEWOLF, but DOG 6 was talking to LONEWOLF using FIPR messages on FBCB2. DEALER MIKE notified DOG 5 that LONEWOLF was on TAC2. DOG 5 requested that LONEWOLF switch to the DOG company net. Approximately 5 minutes later, WHITE 4 was able to establish FM communications with LONEWOLF. At that time LONEWOLF began their move South along RTE CLEVELAND to their screening positions. Elements from LONEWOLF missed their turn on the north canal road so they had to double back. This slowed Team DOG, who had to wait east of the canal road for LONEWOLF to pass but didn't slow down the mission tempo significantly. Once LONEWOLF began their move North to their screening positions, WHITE 1 and WHITE 4 moved south on RTE ██████████ to their blocking positions. WHITE 4 was able to block RTE ██████████ from the south, however WHITE 1 was unable to move to his blocking position due to restricted terrain and was unable to view the objective because of dense vegetation. S05055266(U)

Just as LONEWOLF was getting set, GREEN and RED made their move north along the canal road to the OBJ. As GREEN was moving north, VIPER came out of their hide position and moved to their overwatch positions. VIPER 1 established a position approximately 200 meters due south of Building 7. VIPER 3 was positioned approximately 20 meters east of VIPER 1, and VIPER 3 was approximately 150 meters directly east of building 3. All three teams faced the objective.

At this time DOG 7, 9, and 5 established LZ/CCP X-RAY, and established FM communications with DEALER MIKE using a COM21.

At this time GREEN reached RP MIAMI and began to dismount their squads. RED 1 moved his platoon just North of ██████████ IOT follow and support GREEN. As GREEN was dismounting their squads, LONEWOLF 2 reports that he heard three shots fired from the northwest of his position, he could not identify friendly or enemy. DOG 6 and RED 3 both heard three rounds from the west. During this time, VIPER observed activity on the rooftops of the target compound. At that time, VIPER 3 observed two individuals jump from Building 6 and flee together to the southeast. VIPER 3 fired a warning shot at the runners. One of the runners dove to the ground. VIPER 3 then shot the other runner in the leg to disable him. Shortly after VIPER 3 engaged the runners, VIPER 1 observed a man running from the objective directly at him 15 meters away; VIPER 3 felt threatened and shot the man in the chest. GREEN then began to clear the target compound. One squad moved into Building 7 and then cleared Building 6. Another squad moved simultaneously into Buildings 1 and 3, and then cleared Buildings 2, 4 and 5. S05055266(U)

As GREEN was clearing building 7 VIPER heard an explosion that they could not identify (it was GREEN using flashbang grenades to clear the building). VIPER also heard someone mention an RPG on the net. VIPER 3 then had his team scan the rooftops of the compound more closely. At that time VIPER 1 observed an individual pop up on the roof of Building 5 with something that appears. VIPER 1 thought the individual had an RPG, so he engaged. He shot the individual in the head.

As GREEN cleared the compound, they detained 14 men of varying ages and 23 women and children. The women and children were gathered up and separated from the men. The men were taken to two separate collection points. As GREEN cleared Building 5, they discovered that the individual VIPER 3 shot was a young unarmed female with a toddler. After the buildings were cleared DOG6 gave the order for VIPER to cease-fire. GREEN then began searching the area to the south of the compound north to south until they ran into VIPER. About that time, elements on the ground confirmed that one of the two runners to the southeast was shot in the leg and a MEDEVAC was requested, GREEN continued to search for the second runner but was unable to find him, a body, or a blood trail. In Building 6, two AK-47s and one magazine were found. On top of Building 5, belt fed ammunition was found.

While GREEN was searching the area, RED transported the WIA to LZ X-RAY where he was MEDEVAC'd.

After RED moved the WIA to LZ X-RAY, the 5-ton was called forward to transport detainees. When the 5-ton arrived the 14 men were moved to [REDACTED] STALKER 21 used her source to determine that two of the detainees were associates of Waleed Zelif. The two associates and the 2 x LN KIA were loaded into the 5-ton and escorted by RED to CCP/LZ X-RAY. Once at LZ X-RAY, RED broke off from Team DOG to escort the 5-ton to the Musayyib hospital morgue IOT drop off the LN KIA. After they dropped off the KIA they moved back to FOB ISKANDARIYAH IOT process the detainees. SUSC552 (b)(6)

On OBJ HOUSTON, the rest of the company was consolidating and preparing to return to the FOB. DOG 6 instructed GREEN 1 to release all but two of the men detained. GREEN 1 released the men and then went back inside the compound. The company then started recovery operations on the one stuck BFV, A23, with the help of a tank, D24. WHITE 4 recovered A23 and then IOT withdraw the other three BFVs. WHITE 4 knocked down a cinder block wall. Once GREEN was outside the compound, all remaining vehicles linked up at LZ X-RAY and returned to the FOB. TM DOG RP'd the FOB at approximately 010630JUN06.

9. I, [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On the morning of 01 June 2006 my tank section consisting of my tank and my platoon sergeant's tank was tasked to provide the outer cordon for a raid on a housing complex in the Kanafsa region of AO Dealer. We were tasked to provide the outer cordon for the south-west portion of the housing complex. Our purpose was to insure no one moved in or out of the cordoned area. We overwatched a high speed avenue of approach running north and south that connected to [REDACTED]. I could not actually see the objective housing complex. The vegetation was too thick and our tanks could not move any further than approximately 100 meters north of [REDACTED] due to a canal that could not be passed. SUSCS52(b)(6)

Once the infantry platoon arrived at the housing complex a runner was reported over the net. Seconds later it was reported that the runner had been shot by the snipers. After that it was reported that another person had been shot. Then all houses were reported clear by the infantry platoon. The wounded man received medical attention and was medevaced out. Afterwards the area was searched, the detainees investigated and our vehicles were recalled back to LZ X-Ray in order to begin movement back to the FOB.

9. I, [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

This statement explains the planning involved and sequence of events for Operation Dirty South on the morning of 01 June 2006. This mission was originally planned for the beginning of May but was postponed for various reasons that were not fully explained. The mission was then scheduled to be on the 17th or 18th of May and was again postponed to 01 June. Before each scheduled day the company conducted TLPs in full and was prepared to proceed. These TLPs consisted of OPORD with any changes from previous briefs, rehearsals both map and dress rehearsals consisting of Vehicle Commanders and higher and attachments, and PCCs/PCIs. Each time the OPORD was given it was refined but overall the mission stated consistent in platoon tasks and intent. Intel reported that we were to expect approximately seven males of military age and 10 to 15 females and children. In each rehearsal the ROE was briefed. This ROE stated that if there were "runners", that escalation of force was to be used. This meant that you should attempt to detain the individual first, escalate to warning shots, and last resort shoot to kill. This was reiterated several times in each rehearsal.

My platoon mission consisted of several tasks in support of the main effort, 3rd Platoon. My platoon were to establish Rally Point Miami, which consisted of a CCP and EPW collection point located on the north side of the house near the location of the infantry platoon Bradleys. We also set all vehicles on the main access road to block to the north and detain any individuals attempting to flee to the north. Each one of my vehicles were placed along the road with one M1114 being placed in the driveway of the target house. SSG [REDACTED] was in charge of establishing RP Miami with a count of six dismounts and one interpreter. He was responsible for securing any and all detainees identified by the main effort. Among the dismounts was one medic assisting any wounded soldiers or Iraqis. This squad was also responsible for flexing to any of the buildings to assist in clearing if the main effort was to become bogged down, maintaining the tempo of the raid and have an available M1114 as a chase vehicle.

Upon execution of the operation, the mission went as planned for the majority. Snipers were emplaced by the time we arrived, and the Scouts reported being set on the north side of the objective to observe and screen. The infantry platoon rolled into the objective followed by my platoon with no gap. HQ platoon was tasked to set up LZ X-Ray on RTE [REDACTED] to maintain communications with Battalion. My platoon was able to maintain communications with LZ X-ray. About the time that my platoon was set a shot was taken and followed a few minutes after with another shot. The snipers reported that they had shot an individual on the top of the house that appeared to have a weapon on the shoulder suspected to be a RPG. They reported firing on runners escaping to the south of the objective. All shots had been taken before I gained communications with the snipers. Reports were sent that the individual on the top of the house and one runner had been killed and another runner wounded. The infantry platoon reported clearing six of the seven houses and were taking a large number of detainees. SSG [REDACTED] assisted in clearing the seventh house. The number of males reached 17 and 23 total females and children. The males were detained, being zip striped and blindfolded while the females and children were consolidated and segregated from the males. This number consumed my entire dismounted section. 3rd Platoon reported finding a dead female on the top of one of the houses and the wounded and KIA males on the south side of the objective. Due to the large number of detainees we had to flex additional soldiers to assist in transporting the wounded Iraqi. They reported that the wounded male was continuing to struggle with them even while carrying him on the litter. The WIA was sent to LZ X-ray for medivac. The main detainees were then identified and the remainder of the detainees were released back into the house. At this time my platoon pulled off the objective and allowed recovery of a Bradley that had become stuck. This concluded my platoon's involvement in the mission.

I, [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On approximately 05MAY2006 CPT [REDACTED] gave an OPORD for a raid IVC [REDACTED] to LT [REDACTED], 2LT [REDACTED], 1LT [REDACTED], 1LT [REDACTED], LT [REDACTED], and SSG [REDACTED]. This order outlined the mission of every platoon on the objective. My platoon's mission was to raid a seven house complex in which an EFP cell operated. We were told to expect 3-5 families and at least 6 armed men in the complex. Because of the families being in the house, we did not know if they were going to fight or flee. The ROE was also briefed in which escalation of force was gone over in detail. Shout, show your weapon, block access, warning shot, shoot to wound, and shoot to kill. The snipers' mission was to provide the outer cordon on the southern end of the complex. They were to identify any runners and detainee them, if possible.

I briefed my squad leaders and section leaders approximately four hours after the OPORD. I went over the mission objective, showed the satellite imagery of the houses, and briefed the ROE. All squad and section leaders ran through rehearsals and back briefed me on the plan. At three hours before SP the mission was cancelled due to OPSEC. After everyone stood down, we resumed normal operations in the company. We were stood up for the operation two more times and cancelled at the last second both times. My platoon rehearsed their part of the plan four times before the mission.

On 31MAY2006 my platoon was briefed that we were going to do the raid that night. All vehicles were prepped and PCCs and PCIs were conducted. We Spd at 0040 on 01JUN2006 and moved to CP15. After IPs were picked up, the company moved down [REDACTED] and towards the canal road, after the scouts were in place I moved my platoon up the canal road, turned onto the inlet and moved onto the objective. I dismounted my Bradley Fighting Vehicle and moved in with 3rd squad onto the objective. My 1st squad was held up approx 10 min due to their vehicle getting stuck in the canal road.

While dismounted my MBITER was on my platoon net and I did not monitor company. My PSG stayed in his Bradley and was my relay to the company net as we cleared the houses. My 3rd squad had discovered a body on the top of one of the houses, which was the female. We secured all the women into the courtyard to keep the women away from the body. As a couple of men were tasked with securing the body, the detainees were moved outside the houses and handed over to a SSG from 1st Platoon. The fire team and my 3rd squad leader went searching the back areas for a runner that my PSG had relayed that the snipers reported. At the same time I moved a squad from 1st platoon to help 1st squad secure their buildings. 3rd squad, during their search, found one local national wounded in the leg and another local nation dead. The wounded local national was secured by CPT [REDACTED] and SSG [REDACTED] while SSG [REDACTED] continued to search the area. No other bodies or blood trails were found. An aid and litter team, along with a medic, was moved up to the wounded Iraqi and he was carried to the CCP.

While this was happening 1st squad had secured all the men and women outside of the house and handed over control to a SSG from 1st Platoon. They rechecked the houses for any evidence or personal still hiding in the house. After the buildings had been cleared and the wounded local national evacuated, all the detainees were turned over to the HQ element and moved to the questioning point. During this time all searching of the back areas was completed and my squads regrouped and did a 100% check on personal and sensitive items. After the HQ element questioned all the detainees they released everyone except 2 Iraqi males, they left the objective area and moved a tank onto the canal road IOT recover my stuck Bradley. After the Bradley was recovered and all my other vehicles were moved off of the objective we loaded up and moved back to the FOB.

9. I, [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On 31MAY06 my platoon, which includes the sniper section, was part of Dog Company's Dirty South Operation. On that day we had our second rehearsal for the mission at 1400. The people attending the rehearsal were the Platoon Leaders, Platoon Sergeants, and many of the section leaders. SSG [REDACTED] the sniper section leader, and both of his team leaders were at the rehearsal. During the rehearsal CPT [REDACTED] covered the overall concept of the operation and then each platoon leader was asked to brief what his platoon would be doing during the different phases of the operation. The Sniper Section mission was two-fold: initially they were to infil near the target house and observe the movement around that house and then once the operation began they were to block anyone from fleeing the area on the southern side of the objective. During the rehearsal, I remember the ROE being discussed only very generally in terms of what the R OE says you can do. I do not remember the snipers getting specific guidance.

We departed the FOB at 2030 to take the snipers to their infil point. By the time we arrived, it was dark enough that no one would see them moving. Illumination that night was around 15% and moonset was about 0100. Once the snipers had moved within 200 meters of the target house, they called us with a recommendation to move the hit time forward because there were barking dogs all around them. They were concerned that they would get compromised if the dogs continued barking at them. Soon after I called back to the FOB with the recommendation, Dog Company began their movement towards the objective. As Dog Company moved closer to the turn into the objective area, we began our move. We turned north on the road that runs on the northern side of the canal and moved towards the three bridges we would be blocking. Dog's third platoon, which would be clearing the objective, was approximately 2 minutes behind us on the southern side of the canal. As they turned into the objective the Dog Company net began getting very busy and within 2 minutes all I could hear was people stepping on each others transmissions. Around this time is when I heard the first gun shot and a transmission from the JTAC that CAS has spotted a man running south from the Target House and it looked like he had fallen down. Over the next 5 minutes I heard approximately 7 shots fired to the south of where I was. My vehicle was positioned on the northern side of the canal and 200 meters to the East. From there I could not see what was happening on the objective and I had a difficult time understanding what was happening on the objective because of all of the traffic on the Net. Once the objective was cleared and the situation began to calm down I heard that 2 Iraqis had been killed and another one wounded. Over the next hour we remained in place while Dog Company dealt with the Iraqi casualties and the detainees. At 0430 we collapsed our positions with the snipers and returned to the FOB. Nothing follows.

Regarding the events prior to and during the raid conducted on 1 June 2006. Towards the end of April we were informed of the raid and began preparations. My self and both of my Team Leaders attended the company rehearsals which also included a thorough review of the ROE. We were informed shortly before SP that information had been leaked and the raid was going to be pushed back. On 31 May me and my team leaders again attended company rehearsals which included another ROE brief. Once company rehearsals were completed we returned to our mission planning area and briefed the teams on the current situation, this brief included a very thorough discussion on the ROE. I reminded every one that individuals moving from building to building were not to be engaged by us unless they presented a direct threat to the assault element. Individuals Fleeing the TGT area would be engaged with warning shots first and every attempt should be made to wound any one who continues to flee. At approximately 312030 June 2006 the sectioned SPed the FOB to our insertion point, the sectioned moved along its designated route and established an ORP VIC [REDACTED] a large number of barking dogs and our close proximity to the OBJ prompted me to call the SCT PLT and request Dco move up their hit time, this information was relayed to CPT [REDACTED] and he agreed and initiated movement. Once Dco turned off of RTE [REDACTED] heading for the OBJ, the Sniper Section broke into their teams and began moving toward the OBJ. I crossed a deep canal approximately 50 meters south of the OBJ and began scanning while my shooter PFC [REDACTED] established his position. I immediately detected a large group of people on the roof of a TGT building, the poor illumination compounded by a street light back lighting the OBJ made it impossible to determine gender. Two of these individuals crouched down and started moving for the eastern side of the building. I lost sight of both individuals as they past a date palm and immediately began scanning at ground level. I detected the two individuals running for the cover of a near by canal. I fired one warning shot in front of the lead individual with my M4, he immediately dropped to the ground. The second individual ran through my field of view heading for the safety of the canal, I fired one round at waist level striking the individual in the right thigh. He dropped to the ground and I began scanning for the first individual but was unable to reacquire him. With in seconds of my second shot SGT [REDACTED] came in behind my team and informed me he was unable to move any farther west do to concertina wire and a fence. I instructed him to occupy a position as far to our west as he could and observe the roof tops for possible threats, he selected a position approximately 20 meters from ours. Just as SGT [REDACTED] began to occupy his position an individual came over the fence approximately 10-15 feet from his position, do to the close proximity of this individual and the fact that two rounds had just been fired from this area SGT [REDACTED] perceived the individual as a direct threat to both his team and mine, he fired one round with his M14 striking the individual in the chest. Shortly after his first shot a loud explosion was heard from the OBJ and SGT [REDACTED] fired another round. He informed me that he had heard possible RPG over the net and one of the individuals on the roof appeared to be reading an RPG to fire. My team continued to scan at ground level when I noticed flash light beams and the front of Dco eastern most Bradley, this would be our only notification that Dco was on the OBJ. I instructed all sniper teams to hold fire on the TGT buildings but continue to scan the area around them. With in a couple of minutes I heard SGT [REDACTED] position engage with two rounds. He informed me by radio that he had detected 1 individual low crawling south east of the OBJ and fired a warning shot with his M14, the individual jumped up and began to run, he fired a second round attempting to wound but was unsure if he had hit the fleeing individual. We continued to observe the area around the TGT buildings and contacted CPT [REDACTED] I informed him that we had engaged 5 personnel. As the buildings were being cleared I heard that a female had been killed on the roof, CPT [REDACTED] asked if we had engaged any one on the roof and I confirmed that we had. After the buildings were cleared Dco began securing the out side area finding the WIA that I had fired at as well as the KIA who had been climbing the fence. They were unable to locate the individual I had fired the warning shot at or the individual SGT [REDACTED] had engaged, I believe that the individual SGT [REDACTED] fired upon was the first individual I engaged. Once the area had been cleared we moved onto the OBJ, I found CPT [REDACTED] and informed him about the shot fired onto the roof. We then linked up with the SCT PLT and returned to the FOB. The sniper section was carrying 3 M24 SWS equipped with AN/PVS 10's, 2 M14 rifles equipped with MK4 scopes and locally fabricated AN/PVS 14 mounts, 1 M4 carbine equipped with an ACOG and issued AN/PVS 14 weapons mount [REDACTED]

On the day of ~~May~~ May 30 we were given our mission and the snipers went over the specifics. Our job was to cover the South and west sides of the objective using 3 two man sniper teams. Our ROE was to shoot warning shot and then shoot to kill.

On the night of the 31st we infiltrated 700 meters to our ORP and waited for the call to get set in position. Once Dog company turned down the dirt road to the objective we all (Viper one, two, and three) went to our positions covering our sectors of fire. My team encountered 2 people attempting to run off the objective. I was still setting up so Sgt [REDACTED] took two shots. He hit one of the guys in the leg. Soon after 2 shots rang out from where team one was setting up. One was someone he engaged coming over a fence and the other was a suspected RPG gunner on a ~~the~~ roof top. 2 more shots were fired from team 2's position. They were engaging the other runner trying to get off the objective. After Dog Company cleared the targets we Exfiltrated to the Scout ~~the~~ vehicles and came back to the FOB.

9. I, PFC [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

Half way through the Month of May, we were to be tasked out to support a Delta company raid. The raid was to be of a Compound which was known to house the man responsible for the deaths of PFC Calderon, and Spc. [REDACTED] on April 12th, 2006. We began preparing for the mission with a series of briefs including ROE and the details of our part in the raid. The mission was canceled shortly after due to the lack of information about said mission. Later on in May, we were informed that on the night of the 31st we were to carry out the mission. On the day of the 31st we began prepping for the mission once again. We had our ROE briefings, information about our infiltration was given, our job for the raid, and how we would be extracted. Our ROE on the mission was to fire warning shots, shoot to wound, and then to kill. Our infiltration was to be approximately 1.5 km total, and were to set up an ORP about 150m away from the objective. Once at our ORP we would wait until we heard the vehicles approaching to move to our positions. Once there we were to cut off the Southern and Eastern routes of escape, of anyone attempting to flee the objective. Team 1 (Sgt. [REDACTED] and myself) was to set up directly south of house #7, Team 2 (Sgt. [REDACTED] and Spc. [REDACTED]) were to set up East of the numerous houses next to the dirt road, and Team 3 (Sgt. [REDACTED] and PFC [REDACTED]) were to set up South East of the objective to support Teams 1 and 2. Our exfiltration was to be shortly before the raid called with transportation provided by the Scouts who were staged just

Outside the objective, acting as our QRF. When we arrived at our ORP, we set up security and scanned the area, waiting for our signal. When we heard Delta company approaching, we spread out attempting to make it to our positions on time. When we neared the house, we came across a large ditch, which we had to cross to get to our positions. The ditch was difficult to cross due to its depth and steep walls. When we made our way through our ditch we were near our positions. Sgt. [redacted] then told me to move ahead to find a place to cross what we then thought was a canal. He covered me as I moved ahead. I was unable to find a spot, as the canal was actually a fence. I right with my NVG's only to see two adult males moving through the "backyard" of the houses. At this point I stopped and began to scan the area. As I was dropping to a knee I heard Ssg. [redacted] shoot a round at the males. The round was a tracer, so I was able to see that the shot was a warning shot and it didn't harm anyone. I then heard Ssg. [redacted] fire a second shot at the males which I was unable to tell the aftermath of the shot at the time. I was later notified the Ssg. [redacted] had in fact shot the man in the leg so would hit and to stop him from fleeing. I then heard Sgt. [redacted] announce that he had a runner jumping a fence and moving toward our position where he thought [redacted] was still attempting to move to. He engaged the runner at that line. Very shortly after this I heard him say that he had heard that someone had an RPG and that he was looking around. At this point I told him that I was still near

and he told me to also scan for anyone with an RPG. It was then that he saw numerous personnel on the roof and he directed my attention there as well. He asked Ssg. [REDACTED] if he could engage any of the personnel on the roof if given reason to. Ssg. [REDACTED] said that if he had a clear shot, and that if it would clear all the American soldiers, and he had a legitimate reason to, then to engage. It was then that Sgt. [REDACTED] announced that he saw a person on the roof with something in its hands which he thought would have been said RPG. He re-confirmed with Ssg. [REDACTED] and they engaged. Shortly after this I had heard a gunshot come from Team 2's position. Sgt. [REDACTED] had fired a shot at [REDACTED] what we believe to be the one of the two males who had originally run from the objective. He then fired another shot. None of us had actually known the outcome of any of the engagements until Detta had performed a sweep of the area. It was then that we knew Sgt. [REDACTED] had killed the man fleeing towards our position, and, what we know now, the woman on the roof. When Detta did his sweeps we began to pack up, still scanning the area and pulling security. We then walked to the Scout's location and left the area.
