- Please state your understanding of the Rules of Engagement:  
I can defend myself if I feel my life or coalition forces life is in danger, with lethal force. or use lethal force to protect against Hostile intent
- What were the subjects in the Blue Opal Omega doing on the night of the incident? Why did you pull them over, why did you think they were threatening?  
Breaking curfew, B/c they were breaking curfew. Before the vech stopped he was moving very fast, also he ran from a parked car and pulled a pistol.
- During the time between the blue Opal Omega pulling over, and the suspect being killed, what were his actions that constituted a hostile act?  
The actions were he ran from a vech at gunpoint, then pulled out a pistol
- What action did the suspect take that constituted a Lethal threat?  
Ran from his vech and pulled a pistol
- What threat did the suspect represent to individuals in the patrol, and to the patrol as a whole? His vech could have been a VBIED. and killed alot of IAB and American soldiers also he pulled a pistol and could have shot back at us as soon as he found some cover
- If you could frame one instant or action from the incident that triggered your use of lethal force, what would it be? When he pulled his pistol out as he ran away.

My platoon was conducting a presence patrol and curfew enforcement with a 20 man squad of IAB and a 4 man team of IPs from [redacted] Buick. At approx 0030 we stopped a [redacted] for curfew violation in front of a mosque south of the [redacted] intersection. We had the IPs conduct a search of the car while IAB were pulling security with US forces. About 0055 the electricity in the area went out making the entire area completely dark. I was in the TC's hatch of an M1A1, in the open protected mode (this limits visibility). Just before 0100 a call came over the radio from another tank that a fast moving vehicle was approaching from the south north. Dismounted US and IAB were able to slow and stop the vehicle. Next thing I heard was multiple AK fire in the area of the car. I also saw IAB soldiers converging on the area. Then I saw a spot light from one of the M114s

Shine down on alley way. This was followed by more AK fire and I saw 2 tracer rounds fire. I called [REDACTED] [REDACTED], Contact, contact, East out. A few minutes passed and we started to get reports from the ground. I radioed all info to [REDACTED]. The vehicle was a Blue Opel Omega with 3 occupants. After the vehicle stopped a man in the back seat got out and ran to the east. IAB soldiers said they saw the man carrying a pistol. As the man ran the IAB shot multiple warning shots in the air to stop the runner. An M1114 shined a spot light down the alley and some of our IAB's said they saw the man stop pointing his pistol in their direction. At which time 2 US men shot a few rounds along with the IAB striking the man in the head, killing him. The car was searched as the entire area was cordoned off. The vehicle with the remaining 2 people were detained. In the car was another pistol, [REDACTED] propaganda, and photos some of which seem to be militia or terrorist related. We used the bomb test kit on the KIA and detainees. One of the detainees tested positive for TNT on his hands. We got the 3 mens names and at that time [REDACTED] IP's showed up. They took the body because it was in their AO. I had [REDACTED] IP's take the remaining 2 men. After all info had been radioed to [REDACTED] we began our return trip to the FOB. END OF STATEMENT

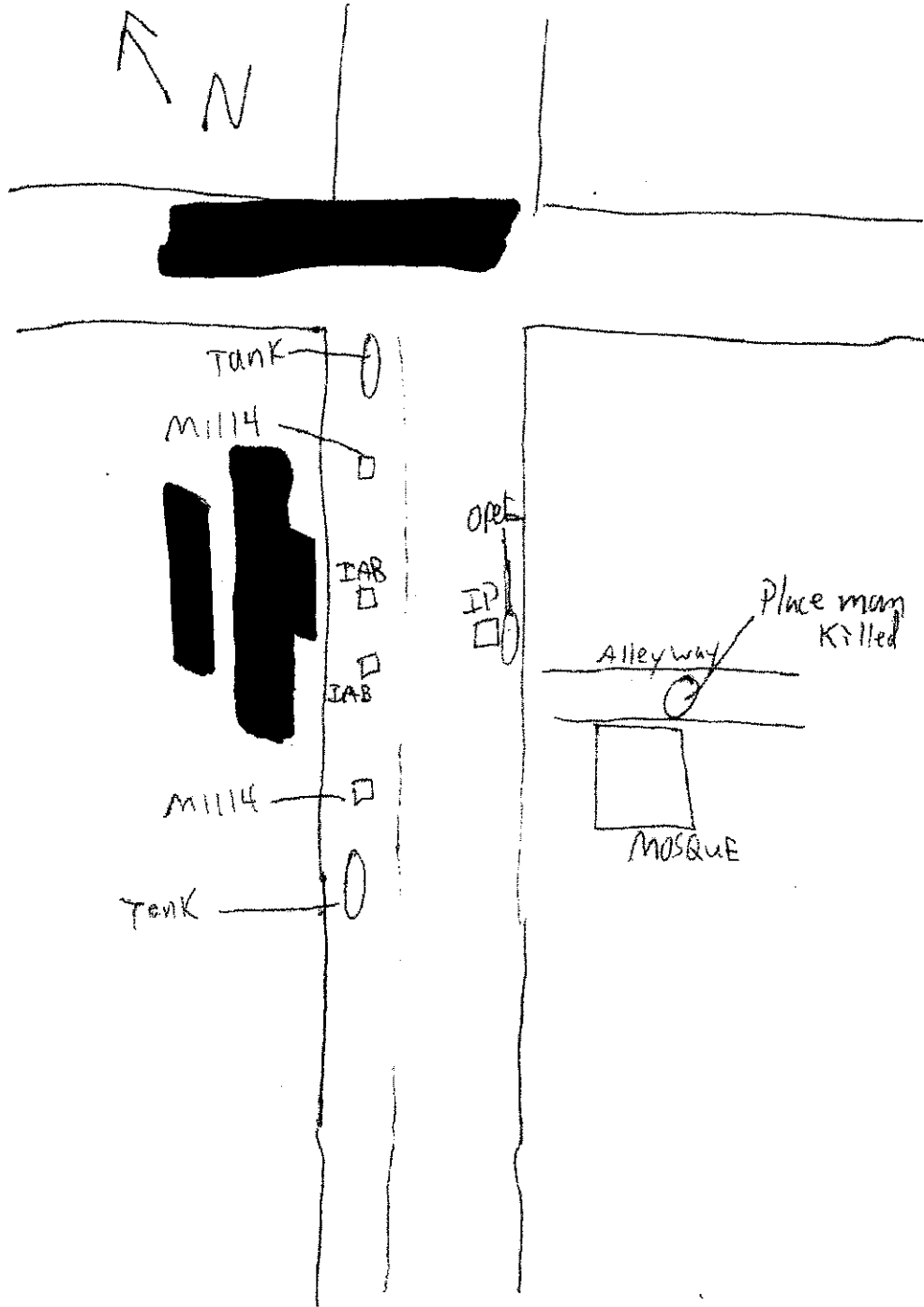

9. I, [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On the night of 28 May 05, Our patrol stopped a vehicle out after curfew. The time frame was around 0100 in the morning. While searching the vehicle the IAB was pulling security for us around the snap TCF.

Since we had just pulled the vehicle over I had gotten out of my vehicle walking toward the one we had pulled over when I saw headlights coming up from behind me. I turned around to see [REDACTED] that it was a blue Opel Omega that had drive right into our perimeter and stopped. As the car was stopping the IAB soldiers who was closer to the Omega than I was started shouting. The passenger jumped out of the car with a pistol on his hip, he darted right and changed his mind, he then went left and ran around the front of the car down toward an alley. The IAB was still shouting by this time the guy was out of my line of sight and the IAB fired shots in the air. I don't know who actually shot the guy but there were a lot of shots fired, The IAB could clearly see the guy running down the alley from their position. I do know that they fired shots in the air. After several shots was fired by several

Different people, not including myself, I ran over to the car assuming that the runner had gotten away. I then searched the other two guys, who was in the car, The IAB had already taken them out of the car and searched them before I got there. They had found a pistol on one of those guys. So I went on and proceeded down the alley where a lot of IAB soldiers had already gone. It was very dark down the alley. I walked maybe about 15/20 meters and an IAB soldier stopped me, and pointed to the ground. I turned on my flashlight and saw the runner lying there dead. His pistol was drawn from his holster lying on the ground beside him. From that point we finished clearing the area

And cuffed the other two guys. The convoy commander (SSG [REDACTED]) was then coordinating with China on further guidance. end of statement.

Q- (CPT [REDACTED]) were the IAB just shooting in the air, or did they appear to also shoot at the suspect?

A- (SGT [REDACTED]) I only saw them shooting in the air.

Q- About how long did this entire engagement take?

A- 15 seconds, 30 seconds maybe.

Q- The spot where the runner was lying, was it too dark to see clearly without lights or NVD's?

A- It was dark enough that it wasn't totally clear, I had to turn my light on to see the body on the ground, but I could see people standing up.

9. I, SGT [redacted], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:
AS we were conducting an after curfew search of a motor vehicle, Another motor vehicle came up the road headed south in the north bound lane. It was moving at a faster than regular speed so I turned my M1A1 gun tube into the path of the vehicle to slow it down and it did but it never stopped until, the IAB squad and the American soldiers pulled the vehicle over with their weapons drawn. Then, Once I saw that the vehicle was stopped. I immediately put my gun tube back where we were conducting our sector of responsibility (scanning). And that's when I heard the gunfire and guys take off after someone out of the vehicle running down an alley. At the same time I observed two men get on their knees with their hands up. And then that's when I radioed up what I saw to my platoon leader what I observed. And then my crew proceeded to continue scanning our sector as there was a crowd of Iraqis beginning to form up out the alley near my vehicle. I didn't see anyone get shot or do I know who shot what rounds. End of Statement. [redacted]

We had pulled over for a Snap TCP and I was covering an alley that was right beside where they (IAB) and some US forces were searching cars. The area we were in was a dark place so I was wearing no shoes. The area behind me was a dark ally that was very big and had poor lighting. When the Blue opal arrived I didn't pay much attention to it. Then all the sudden I heard alot of shouting going on to my rear, so I swung my turret around to see what was happening. I was a man with a plaid shirt on raising his hands yelling, then all the sudden the man took off around the car and into the Big open alley. The IAB began to fire shots at something. I couldn't make out where the guy was. There were a few guys running at the back of the alley and one close. I grabbed my spot light and shined it into the alley for about 10 seconds. I had found the man they were tracking and held the light of him for a few seconds. He did appear to have something in his hand but I couldn't tell what it was. All the sudden I heard a noise back behind me in the alley that I was covering, and figured the threat that I was covering was being handled by enough people, I swung my turret around back to that alley and saw there were people there had heard the shots and watching the actions of us. I cleared them out of the way and kept scanning my alley, since all the shooting had expired.

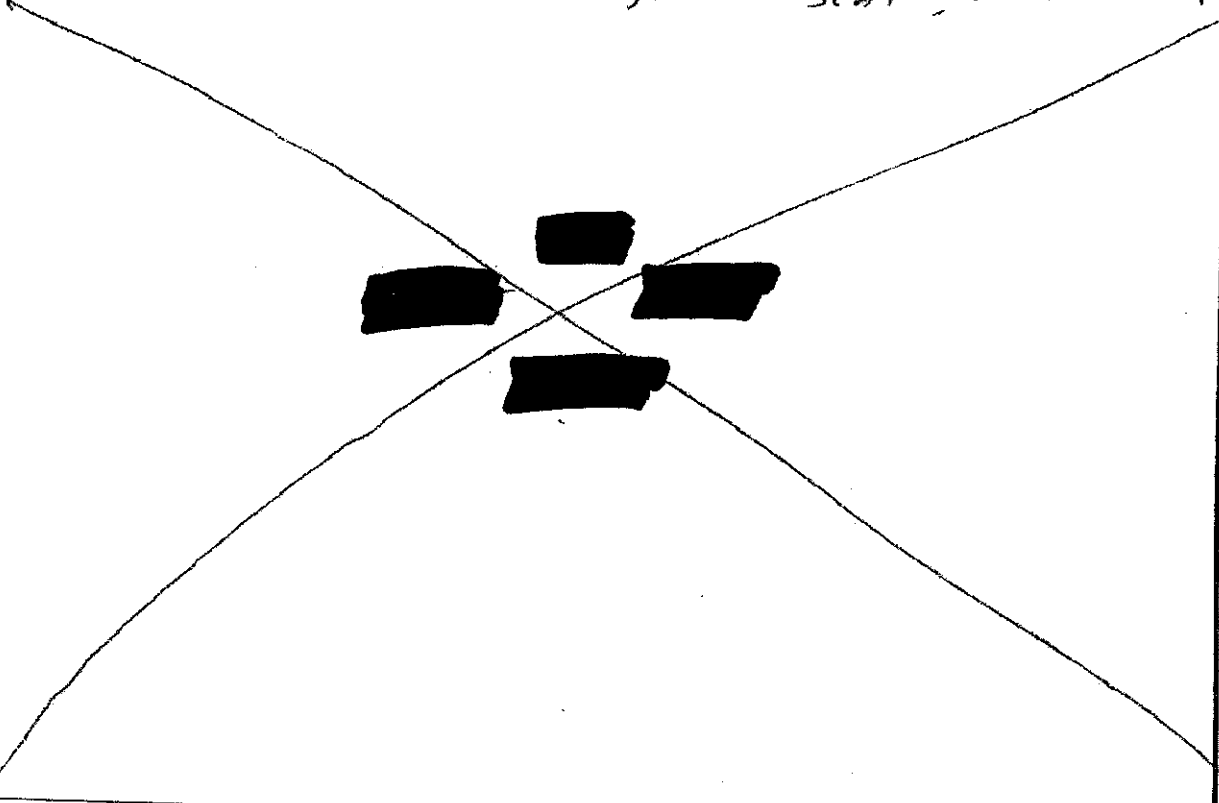

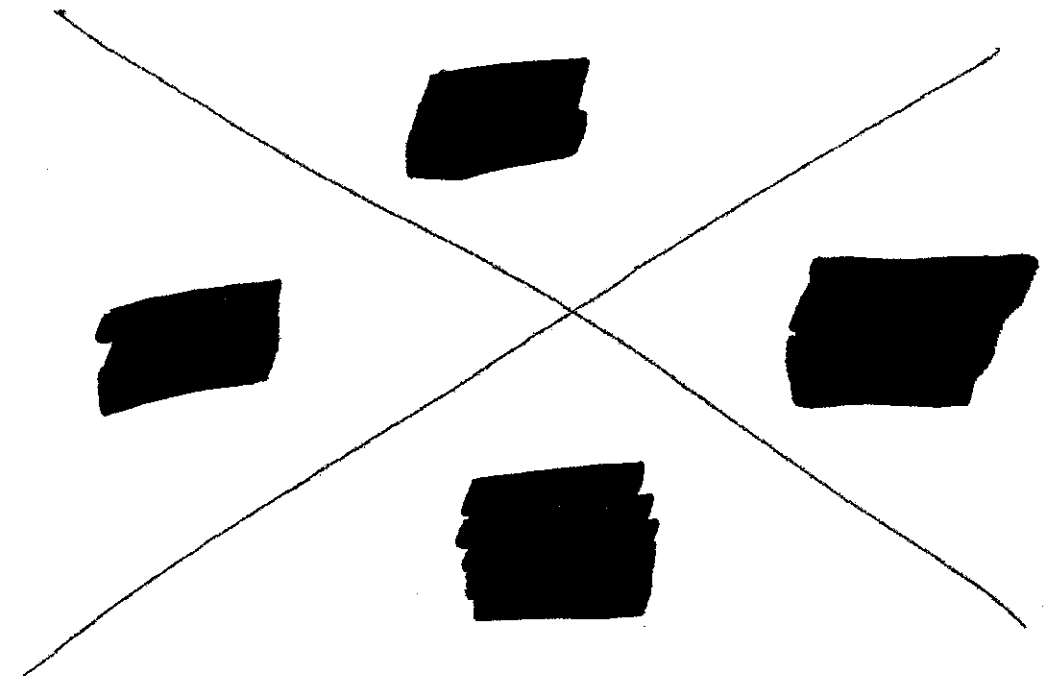
