I WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

I was the TC of the 2<sup>nd</sup> RG-31 (3<sup>rd</sup> in patrol). I was sitting up front next to the driver. We were traveling east on Rte [REDACTED] in between [REDACTED] and the [REDACTED] interchange. The [REDACTED] stopped us to interrogate something so I had my vehicle stop and began our 5/25 meter scans. After we cleared the area around my vehicle, I began scanning rooftops. I looked out the front windshield in time to see the first RG-31 stop partially in the median. SPC [REDACTED] the gunner, had his stop sign in his left hand and his M16 in his right hand. SPC [REDACTED] fell into his M2 machine gun and I saw a puff of smoke from the barrel. I wasn't sure if it hit the LN truck that was heading west on [REDACTED]. I saw the driver of the truck open his door and fall on the road. The 1<sup>st</sup> RG-31 called the medic up to treat the LN. So SPC Paynter's vehicle moved up to the LN truck. The 1<sup>st</sup> RG-31 moved into the westbound lane, next to the LN truck and dismounted 2 personnel. Once the medic was up there they found another wounded LN in the truck. My vehicle moved back to take up our security as the [REDACTED] moved up to assist the medic. The 4<sup>th</sup> vehicle, LT [REDACTED] moved up to the LN vehicle as well. About this time, we were informed that one of the LN's had a faint pulse and needed a bird. We had 2 M1A1's move to our location and take up rear security, so my gunner, SPC [REDACTED] oriented his weapon to the three o'clock position. A few minutes later, we were told that one of the LN had D.O.W. The helicopter landed in the west bound lane and the wounded LN was loaded onto the bird and it departed. Another unit came and moved the LN truck off of the road and secured it. Then the body was surrounded by our vehicles until vehicles 4 and vehicles 5 moved it over to the truck.

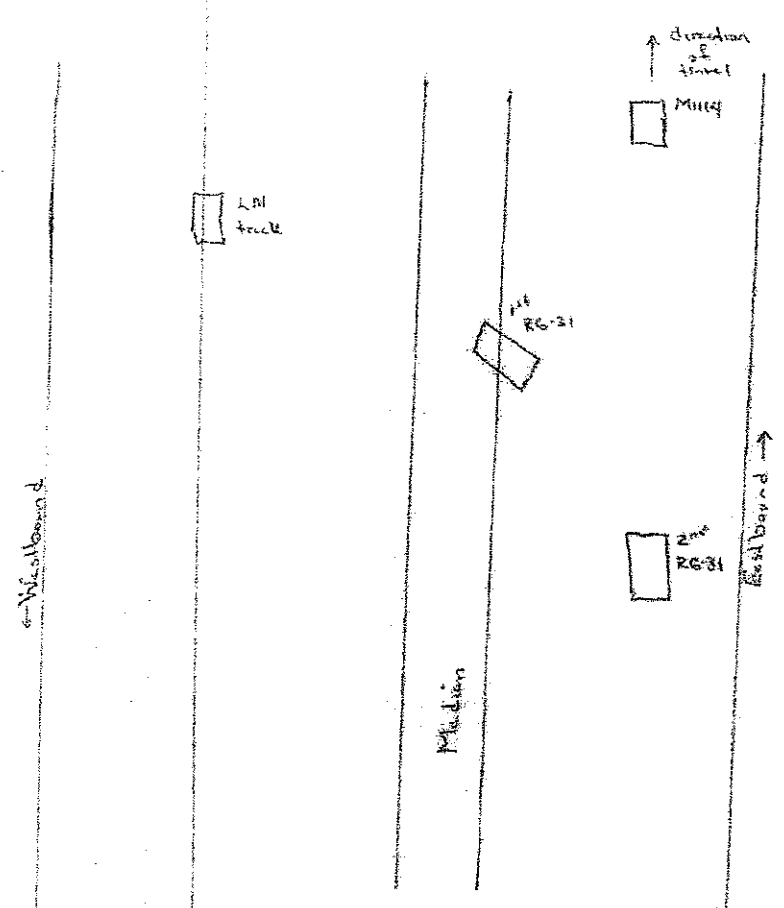

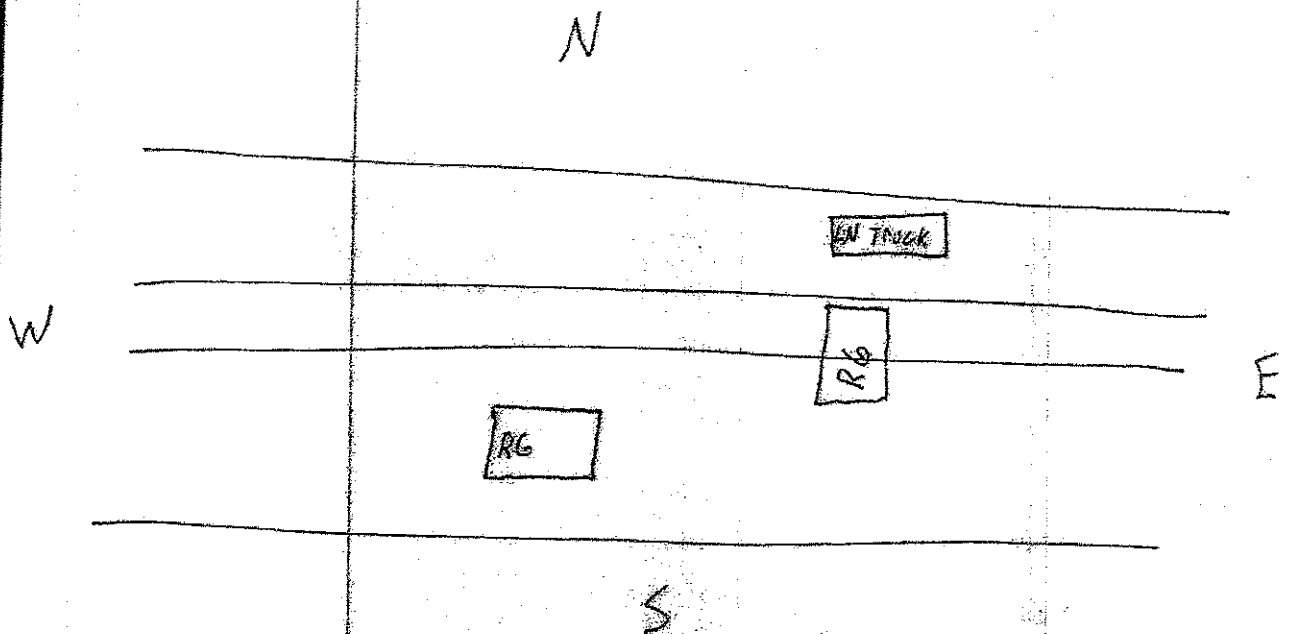

9. I, [redacted], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

I was in the third vehicle of an iron claw convoy on November 10 2005. Our convoy was on a sweep of route [redacted] at 1036 heading east near [redacted] we stopped, then I heard a round fired. I looked out the front of the vehicle to see where the shot came from. I saw a man open up the door of his truck and fall out of it. At that time I then heard someone on the radio say that we needed to get medical personnel up to the truck because someone had been injured. The medic's vehicle came up to assist the injured immediately. I then heard someone call on the radio to LT [redacted] and told him that we needed a medevac bird. That same person reported the injuries as two urgent surgical. Shortly after that a person came on the radio and updated the status of the injured to one with a faint pulse and barely hanging on, and the other one with surgical urgent. Again, a short time later, someone came on the radio and updated the statuses of the casualties as one kia and one surgery urgent. The bird landed at 1100 to pick up the urgent surgical. We waited there for a while. We then switched lanes and kept a tight triangle formation with the buffalo and at least one other vehicle. A humvw came and took the casualties vehicle to the access road and dropped it off there on the north side of route [redacted]. Again we waited for maybe 15-20 minutes at which time the litter team exited the [redacted] and loaded the casualty into the hood of a humvw. They took the kia casualty to the truck and unloaded hi onto the bed of the truck he was riding in. we then continued mission.

The [redacted] called up that they were going to interrogate something. ~~On~~ My vehicle came to a stop and started doing our S/25 scans. Vehicle 2 (R0-31) pulled up to the median to stop traffic traveling West on [redacted]. I saw [redacted] holding up this stop sign and that all vehicles were stopping. I saw a white truck heading West bound who was starting to stop, and was almost completely stopped. That is when I heard a single shot from the SO cal. I asked my T.C. (Sgt [redacted] if he knew why [redacted] shot the SO cal. Sgt [redacted] said he didn't know and thought it may have been an accident. I then saw the driver <sup>(EN)</sup> dismount his truck and lay on the ground. Then SSG [redacted] called on the Radio that the LN needed immediate medical attention. AT [redacted] (5th vehicle) told my vehicle to move back and take rear security. The 2 LN's received medical attention, then the bird flew in and took 1 LN. We continued to pull security till the LN's truck was towed and till we figured out what to do with the LN KIA. The LN truck was towed by another U.S. military unit.

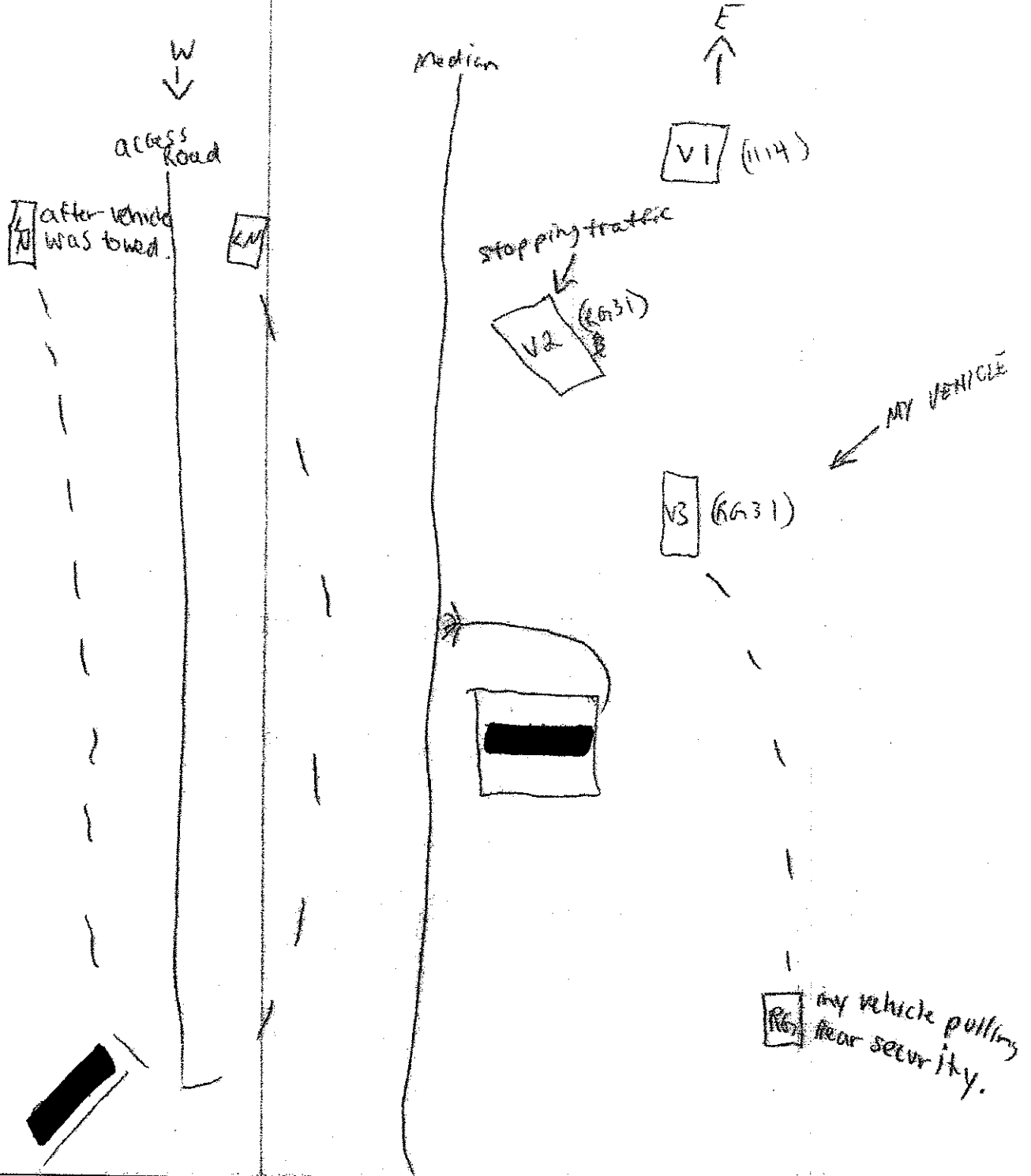

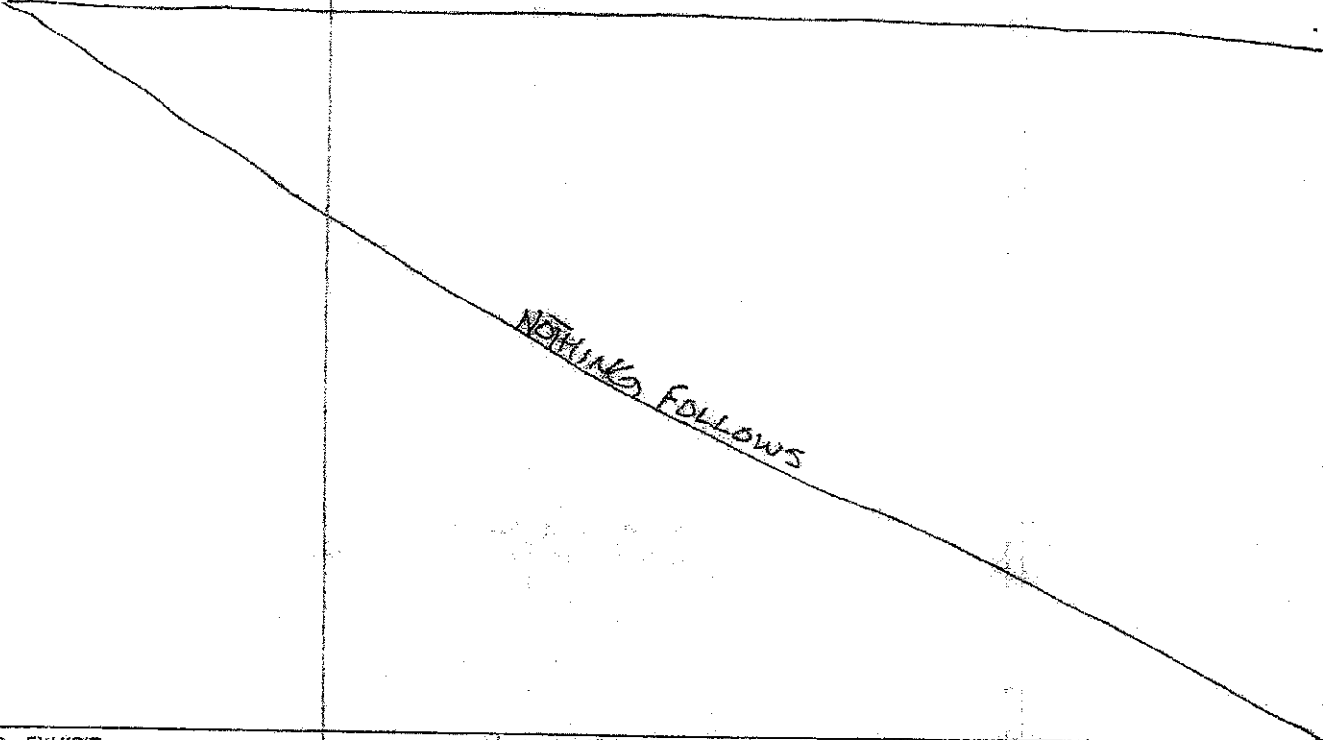

I, [redacted], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On November 10, 2005 at approximately 1025 hours, we were traveling east on route sword. I was in the 3rd vehicle in the convoy the 2nd RG-31. The [redacted] stopped to interrogate a suspected IED. The 1st RG began to stop traffic and move their vehicle toward the median. After traffic was stopped one truck continued to drive. The gunner of the 1st vehicle continued to yell and wave his stop sign at the vehicle. The vehicle stopped and the driver got out and fell to the ground. The 1st RG called out someone had been shot and that they needed medical assistance. They moved their vehicle over to the westbound lane. They had two dismounts go and start giving medical treatment to the wounded local national. The last vehicle in the convoy, the Platoon Sergeant and medics hmv moved up to the site of the casualty. Next we moved our RG to the rear of the cordon and provided rear security. The [redacted] then moved to the westbound lane to assist the medic with the casualty and security. The 4th vehicle in the convoy the Platoon leaders hmv moved its vehicle to the westbound lane. Someone on ground went to the passenger side door to help the passenger. They forced it open and got the other local national out of the truck. Someone for the ground crew called out an assessment of the casualties; they said they had two surgically urgent local nationals. They also requested a [redacted] sent up. Two dismounts set up a vs 17 panel for the bird to land. The ground crew then called out over the radio that one local national was now KIA. The bird arrived and loaded up the other casualty. We then moved our vehicle into the westbound lane and also the 1st vehicle.

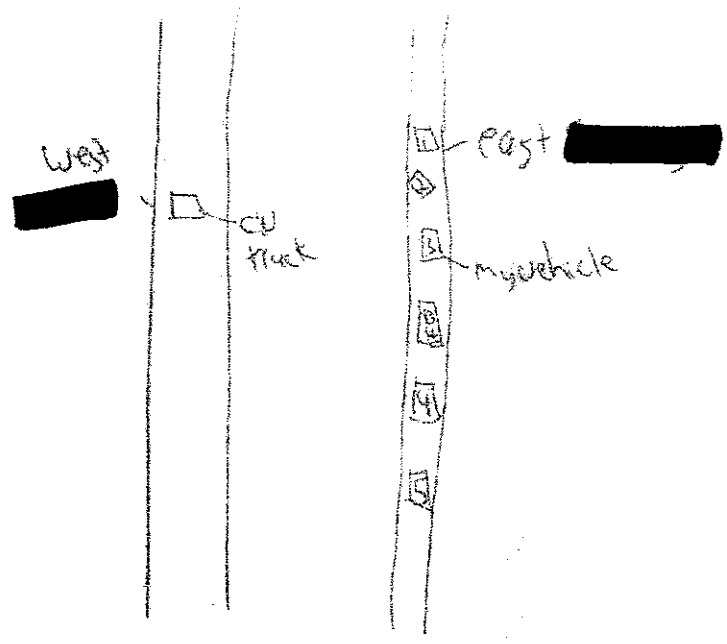

On 10 November 2005 we were traveling East on [REDACTED]. The [REDACTED] was interrogating an object and I was in the second RG-31 seated on the right side behind the front seat passenger. As we were doing our scans across the vehicle stopped, I heard a popping sound and looked forward. I saw the first RG stopped and looking over and saw a white truck which was traveling but was stopped west on [REDACTED]. Then I saw the driver open the door and fall onto the ground. At that time, I saw the first RG-31 go over to where the victim was laying. After that I quickly turned my head and started to scan the buildings in our sector. As the rear vehicles pulled forward to assess the situation our vehicle backed up and pulled rear security. During this time there was constant communication on the status of the victims. During this time we learned that one individual was KIA due to a .50 caliber round. A medical helicopter came and took the first victim away for medical treatment. After the helicopter took off, all of the vehicles formed a box around the KIA. Soon after other US soldiers pulled up and toward the [REDACTED] victims took off at the highway and placed [REDACTED] in the box formation for a little while the killer team picked up the body and the which was on a stretcher and placed it on the hood of one of the Humvees. They then drove to body over to the victims truck and placed the body in the bed of the truck. After that we continued our mission.

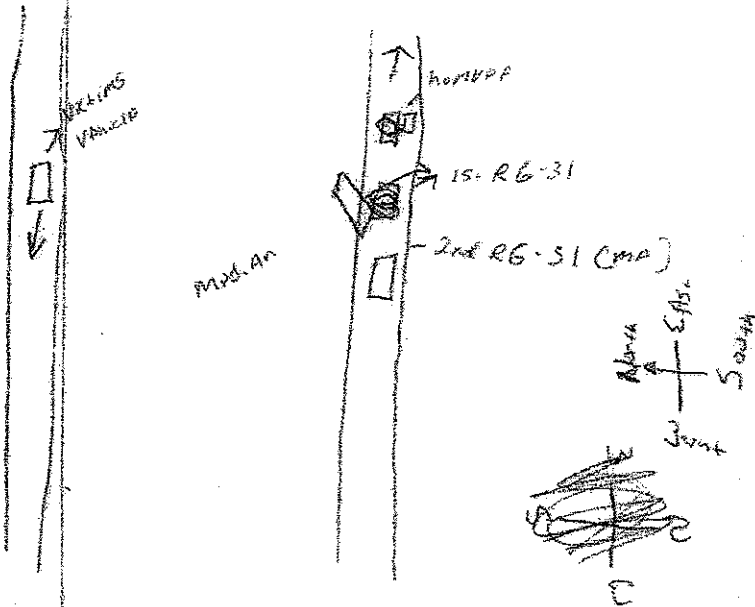

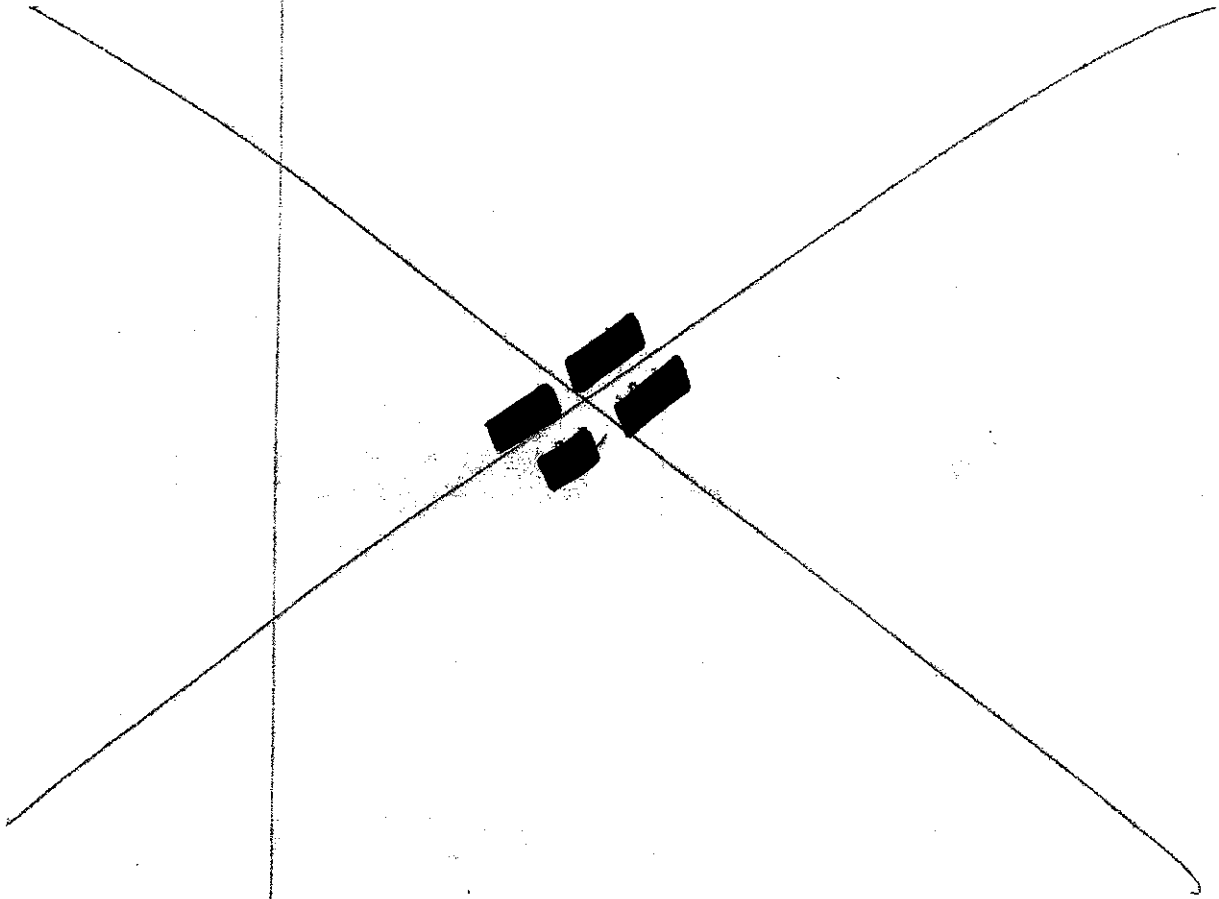
