SUBJECT: Appointment as AR 15-6 Informal Investigating Officer

1. You are hereby appointed as an investigating officer to conduct an informal investigation IAW AR 15-6 into the vehicle accident that occurred on 7 March 2008 and resulted in the death of a local national.
2. The scope of the investigation should include the following:
 - a. The facts and circumstances surrounding the accident on 7 March 2008;
 - b. The identity of those injured in the accident, the extent of those injuries, and the medical care given after the accident occurred;
 - c. The mission of the convoy at the time of the incident, including mission planning, safety, illumination data and risk assessment planning;
 - d. A determination of the cause of the accident;
 - e. The nature and extent of loss or damage to military equipment; and
 - f. Recommendations concerning improvements, if any, to coalition force techniques, tactics and procedures on future missions.
3. This will be an informal AR 15-6 investigation. This will be your primary duty until completed and takes precedence over all other duties and assignments. All statements will be in written form and sworn, using DA Form 2823. If witnesses have redeployed, seek to conduct telephonic interviews of them at their home station.
4. If, during the course of the investigation, you suspect that anyone involved has violated any criminal laws, you should advise that person of their Article 31 Rights, prior to questioning. If anyone attempts to interfere with or obstruct your investigation, notify the appointing authority immediately.

EXECUTIVE SUMMARY

On 07 MAR 2008, a five vehicle convoy was moving from Camp Clark to FOB Salerno. The mission of the convoy was to pick up the (b)(2)High team at FOB Salerno. An additional important task was to conduct a left seat/ right seat ride with incoming and outgoing personnel from the Navy garrison at Camp Clark. The convoy commander was US Navy LT (b)(3), (b)(6). The TC of (b)(2)High was US Navy CDR (b)(3), (b)(6). The driver of (b)(2)High was US Navy CDR (b)(3), (b)(6). At approximately 1030L, the lead (b)(2)High struck a local national (LN) farm tractor with trailer (tractor/trailer) that had pulled to the right side of road near FOB Chapman. A LN fell off the vehicle and suffered a head injury. A US CLS treated the LN on the scene before he was sequentially evacuated to FOB Chapman, FOB Salerno, and BAF where the LN subsequently died.

The convoy commander, truck commander, and driver all acted properly before, during, and after the vehicle accident. The driver and TC of the (b)(2)High made a reasonable decision to pass the farm tractor with trailer, and the driver executed the passing maneuver with appropriate speed and caution. The driver did, however, misjudge his position between the tractor/trailer on the right side of the road and the white sedan on the left side of the road. This was the proximate cause of the accident. During this investigation, the accident was the result of simple negligence (failure to adequately judge distance), there was no evidence to indicate, any recklessness, gross or criminal negligence as a factor, this incident was an unfortunate accident.

US Navy CDR (b)(3), (b)(6) should complete additional driver training that has special emphasis on negotiating obstacles similar to those frequently found on the roads of Afghanistan. The commander of PRT Khowst has already made a solatia payment to the victim's family. No additional payments should be made. However, the PRT commander or other appropriate US commander should make a personal apology to the victim's family (if he has not already done so). This will help minimize the damage to the relationship between the local population and US forces that has likely occurred as a result of this unfortunate accident.

SECTION IV - FINDINGS (para 3-10, AR 15-6)

The *(investigating officer) (board)*, having carefully considered the evidence, finds:

On MAR 2008, a five vehicle convoy was moving from Camp Clark to FOB Salerno. At approximately 1030L, the lead (b)(2)High struck a local national (LN) farm tractor with (tractor/trailer) that had pulled to the right side of road near FOB Chapman. A LN fell off the vehicle and suffered a head injury. A US CLS treated the LN on the scene and he was sequentially evacuated to FOB Chapman, FOB Salerno, and BAF where the LN subsequently died (Exhibit 1).

Prior to executing the CONOP, the convoy commander, US Navy LT)(3), (b)(submitted a convoy operation (CONOP) plan and conducted a convoy brief where he directed that speeds should be reasonable but should not exceed 40 mph. The TCs and drivers in the convoy complied with these instructions including slowing to 10-15 mph when road traffic in Khowst dictated (Exhibit 2). Weather conditions were excellent and road conditions were mediocre - neither were a factor. Traffic density was moderate to heavy. Traffic was a factor in that it forced LN vehicles traveling west (i.e. the tractor) and east (LN white sedan) to pull-over and stop at the same point on the road and create a only small, but adequate lane for the convoy to use to pass (Exhibit 3). As(2)Hiapproached the small lane between the sedan and the tractor, the driver, CDR(3), (b) slowed his speed and considered stopping. He confirmed his quick assessment that he had room to pass by asking gunner, Petty Officer)(3), (b) and Truck Commander, CDR(3), (b) for their assessment. (Exhibit 4). CDR(3), (b) was trained and licensed to operate a UAH (Exhibit 5). He also had extensive experience driving UAHs and other military vehicles including driving in the snowy and icy conditions common during the winter in Afghanistan. As a US Navy pilot, CDR(3), (b) also had significant training on safety and risk management (Exhibit 4). There was adequate room for(2)Hto pass -- 2-3 feet clearance (Exhibit 6). Petty Officer)(3), (b)confirmed to the driver that there was sufficient room. CDR(3), (b)proceeded through the lane slowly, but misjudged his position and drove too close to the right side and struck the trailer (Exhibit 7, Exhibit 4). As CDR(3), (b) CDR(3), (b)negotiated the lane, he realized that he was too close to the tractor. However, the impact occurred before he could apply the brake. The minimal space between the vehicles parked on the sides of the road was an important factor (Exhibit 4). The speed at the time of impact was 10-15 mph (Exhibit 6). As a result of the impact, the front right "Frag 5" kit of(2)H struck the rear of the tractor/trailer and the Window/Frag 5 kit sheared from the body of the UAH. The right rear window/Frag 5 kit was also severely damaged (Exhibit 3, 4, 6, 8). The damage to the window/ Frag 5 kit in the type of impact previously described is consistent with the technical knowledge and experience of the Frag 5 technicians at Camp Clark. The bolts/connectors that hold the Frag 5 kit are not designed to withstand shear forces like the force applied to them by the low speed impact of(2)Hand the tractor/ trailer. Speed was not a significant factor (Exhibit 9). There is no evidence that medical care provided to the injured LN by the CLS on the scene and medical personnel at Chapman, Salerno, and BAF was anything but appropriate, or that any other actions could have saved the life of the local national after his injury.

The convoy commander, truck commander, and driver all acted properly before, during, and after the vehicle accident. The driver and TC of the UAH made a reasonable decision to pass the farm tractor with trailer, and the driver executed the passing maneuver with appropriate speed and caution. The driver did, however, misjudge his position between the tractor/trailer on the right side of the road and the white sedan on the left side of the road. This was the proximate cause of the accident. During this investigation, the accident was the result of simple negligence (failure to adequately judge distance), there was no evidence to indicate, any recklessness, gross or criminal negligence as a factor, this incident was an unfortunate accident.

- b. Weather conditions were excellent and road conditions were mediocre - neither were a factor. Traffic density was moderate to heavy. Traffic was a factor in that it forced LN vehicles traveling west (i.e. the tractor) and east (LN white sedan) to pull-over and stop at the same point on the road and create a only small, but adequate lane for the convoy to use to pass (Exhibit 3).
- c. As)2)(Hi approached the small lane between the sedan and the tractor, the driver, CDR)3), (b)(6 slowed his speed and considered stopping. He confirmed his quick assessment that he had room to pass by asking gunner, Petty Officer)3), (b)(6 and Truck Commander, CDR)3), (b)(6 for their assessment. (Exhibit 4).
- d. CDR)3), (b)(6 was trained and licensed to operate a UAH (Exhibit 5). He also had extensive experience driving UAHs and other military vehicles including driving in the snowy and icy conditions common during the winter in Afghanistan. As a US Navy pilot, CDR)3), (b)(6 also had significant training on safety and risk management (Exhibit 4).
- e. There was adequate room for)2)(Hi to pass -- 2-3 feet clearance (Exhibit 6). Petty Officer)3), (b)(6 confirmed to the driver that there was sufficient room. CDR)3), (b)(6 proceeded through the lane slowly, but misjudged his position and drove too close to the right side and struck the trailer (Exhibit 7, Exhibit 4).
- f. As CDR)3), (b)(6 slowly negotiated the lane, he realized that he was too close to the tractor. However, the impact occurred before he could apply the brake. The minimal space between the vehicles parked on the sides of the road was an important factor (Exhibit 4).
- g. The speed at the time of impact was 10-15 mph (Exhibit 6). As a result of the impact, the front right "Frag 5" kit of)2)(Hi struck the rear of the tractor/trailer and the Window/Frag 5 kit sheared from the body of the UAH. The right rear window/Frag 5 kit was also severely damaged (Exhibit 3, 4, 6, 8).
- h. The damage to the window/ Frag 5 kit in the type of impact previously described is consistent with the technical knowledge and experience of the Frag 5 technicians at Camp Clark. The bolts/connectors that hold the Frag 5 kit are not designed to withstand shear forces like the force applied to them by the low speed impact of)2)(Hi and the tractor/ trailer. Speed was not a significant factor (Exhibit 9).
- i. There is no evidence that medical care provided to the injured LN by the CLS on the scene and medical personnel at Chapman, Salerno, and BAF was anything but appropriate, or that any other actions could have saved the life of the local national after his injury.

MEMORANDUM FOR RECORD

SUBJECT: 15-6 Investigation into the Convoy Accident that Resulted in the Death of a Local National on 7 March 2008 near FOB Salerno.

1. The Investigating Officer (IO) found that the UAH^{(1)(2)Hig} driver and truck commander misjudged the amount of space needed to pass the parked tractor on the side of the road. The collision knocked the local national off the tractor. Medical personnel applied appropriate treatment but could not save the local national's life. The IO found that the driver's negligence caused the accident. I approve the findings and recommendations of the investigating officer.
2. The recommendation that the unit add additional driver training that has special emphasis on negotiating obstacles frequently found in Afghanistan is returned to the unit for appropriate action.
3. The investigation is returned to the unit for appropriate action consistent with the IO's findings and recommendations and my additional instruction above.

I, (b)(3), (b)(6) , WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On 7 March 2008, I was the convoy commander of a five vehicle mission in Khowst, Afghanistan. The order of march was (2)Hi driven by CDR (3), (b)a brigade mentoring team UAH from the S4 department commanded by CPT(3), (b) an LMTV from the same detachment, SAL4 driven by PS2b(3), (b)6 and myself in (2)-Hi at the rear of the convoy. Approximately half the crews were experienced personnel, scheduled to RIP within the week, and half were their replacements. Our primary mission was "left seat / right seat" with these personnel. Our intelligence reports indicated numerous (2)HIED's in Khowst, including tractors and flatbed trucks, in addition to the usual reports of small sedans or vans. During the convoy brief, I instructed my TC's to maintain a reasonable speed, not to exceed 40 mph. with an emergency speed of as high as 50 on open terrain. I urged the importance of not posing a reckless threat to traffic outside the convoy, (b)(2)High

(b)(2)High Throughout the first portion of the convoy, I estimate our average speed never exceeded 35 mph, and was perhaps as slow as 10 to 15 once we entered downtown Khowst. I was very pleased with how well we were proceeding, and noticed no reckless or overtly aggressive behavior from any of the crews. Approximately one half mile from FOB Chapman, I noticed the LMTV's break lights slowly come on, and within seconds, received a call from CDR(3), (b) that the convoy was halted, and there was an Afghan injured. Since I had the interpreter in my vehicle, and could not visibly see what CDR(3), (b)situation was, I gave command over to my relief, LT(3), (b)(e for)(2)Hi and took our linguist, (b)(6) and CPT(3), (b)to the wreck site. I instantly noticed that there was an Afghan male, approximately 30-40 years of age, lying on his back, to the right side of his tractor, which, for the exception of minor damage to the trailer, seemed perfectly operable. A small boy, perhaps 3 or 4 years old was kneeling next to him and crying. The man was unable to speak, seemed to be convulsing, and had blood at the corner of his mouth. I noticed no other obvious injuries, assigned CPT(3), (b)to stay with him and begin CLS, and proceeded to DR (3), (b)UAH to have his TC send up a MEDEVAC request via FM and FIPR to the 1/203rd TOC. As we had no medics or assigned medical personnel, I returned to PS2's UAH to see if DCCS(3), (b)fa fire fighter in the civilian sector, could be of any assistance. He and (b)(6) immediately returned to the victim, and I returned to (2)Hi to update the 1/203rd of the situation, and to ensure our convoy was maintaining tight security, as there were from 30 to 40 civilians milling about the scene. I also took notice that approximately 15 minutes had passed since we first halted the convoy. Within another 4 or 5 minutes, DCCS informed me that there were serious injuries involved, but that he could not be sure of the full extent. I had not received confirmation hat the MEDEVAC was approved, and seeing that FOB Chapman was so close, I had (b)(6) order the Afghan police (who arrived on scene during the first few minutes), take the man inside to the TMC, with my convoy in support. Soldiers from CPT (b)(6) team assembled a litter, put the Afghan on their truck, and took his nephew and our interpreter into Chapman; we followed closely behind. Once inside, I took stock of the damage to CDR(3), (b)UAH, and determined it could not be safely driven to Salerno. After discussing the case with one of the OGA personnel present, we decided to allow the Afghan police to work with the U.S. personnel at Chapman to get the boy back to his family, and seeing as how we could get no useful information from him, proceeded to hook up (2)Hi for towing behind (2)Hi. At this time, the U.S. personnel at Chapman informed me that due to the serious nature of the man's injuries, he needed to be transported to Salerno as soon as possible, and the Afghan police immediately left with our convoy about five minutes or more behind as I needed to coordinate leaving the damaged vehicle's crew behind until we could affect repairs at Salerno. We preceded without incident the rest of the way to FOB Salerno, dropped off (2)Hi to have the door repaired, and went to the hospital to check on the victim. The attending doctor informed me that they were going to MEDEVAC him to Bagram. We continued our mission in Salerno, and then proceeded back to Camp Clark around 1600L, via FOB Chapman to pick up the personnel I had left behind, without incident.

I, (b)(3), (b)(6) , WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

I was the truck commander for the lead vehicle (c/s (b)(2)High 1 of a convoy proceeding from Camp Clark to FOB Salerno along Route Hammer on the morning of Friday, 07 March 2008. My vehicle crew consisted of driver CDR (b)(3), (b)(6) and gunner IT2 (b)(3), (b)(6). Weather conditions were clear and sunny. Visibility was unrestricted. Road conditions along the route were evaluated by me as mediocre due to numerous pot holes and other unrepainted areas. The road was two lane pavement in construction, designed for one lane of traffic in each direction. Traffic density ranged from moderate to heavy. Local national vehicle traffic was generally complying with the practice to maneuver to the shoulders of both lanes to permit passage of military convoys. Our vehicle, an M1114 Humvee, appeared to be operating normally in all respects.

At the time of the incident, we were navigating through the poor road conditions, and vehicle and pedestrian traffic, using a combination of speed adjustments, turning maneuvers and vehicle siren. Gunner(3), (b)(6) and I were monitoring vehicle and pedestrian traffic for possible threats and safe conduct of our vehicle and the balance of the convoy behind us. We were providing pertinent information to driver(3), (b)(6) via the internal communication system when appropriate or as requested. As our vehicle headed west and passed by the turn to FOB Chapman, we observed a farm tractor and brightly colored open trailer approximately 75 yards ahead of us. The tractor and trailer appeared to be either stationary or coming to a halt. It was straddling the narrow shoulder and our traffic lane, with the trailer extending approximately 4 feet into the traffic lane. I recall two local national personnel in the vicinity of the tractor/trailer. One person appeared to be standing in the bed of the trailer. I do not have a firm recollection of where the other person was at the time of the incident, as I was focusing on the maneuvering and position of the oncoming traffic. The oncoming traffic, lead by a white sedan, maneuvered to stop directly across from the tractor/trailer. The vehicles in the oncoming lane also straddled the shoulder and lane of traffic, leaving the convoy a narrow clearance for passage. Driver(3), (b)(6) slowed the vehicle and requested that gunner(3), (b)(6) and I assess if we had adequate clearance to pass between the stopped vehicles. We concurred that there was adequate clearance. Driver(3), (b)(6) maneuvered and accelerated to pass between the vehicles. It was not apparent that our maneuver was slightly too far to the right until just prior to the collision.

The point of collision occurred between the left side of the trailer and the passenger side of our vehicle. The truck commander door window was torn from the door, with the handle for the window glass ending up in my lap. Driver(3), (b)(6) promptly maneuvered the vehicle to the shoulder of the road and stopped approximately 25 yards ahead of the tractor. CDR(3), (b)(6) notified the convoy commander, LT (b)(3), (b)(6) of the incident, and directed that all involved parties prepare and submit witness statements at their first opportunity. The convoy was halted and appropriate security was ordered and set. Other elements of the convoy observed a middle aged local national male prone on the ground in the vicinity of the tractor. Members of our vehicle did not dismount for the duration of this stop. Several convoy members dismounted to investigate the accident scene and determine if any injuries were sustained. The local national male was conscious but apparently seriously injured and in need of immediate medical attention. There was minimal damage to the trailer. Any substantial vehicle debris recovered at the accident site was placed in convoy vehicles for further disposition.

Convoy commander(3), (b)(6) notified the Camp Clark Brigade TOC of the incident and requested medical assistance. Dismounted convoy personnel provided first aid to the injured local national male pending arrival of emergency medical services from FOB Chapman. Convoy commander(3), (b)(6) directed that the convoy divert to FOB Chapman to revise the convoy plan and identify the plan of action for the damaged Humvee. The victim, along with the juvenile local national male who was apparently related to the victim, was evacuated by ground transportation to FOB Salerno. It is my understanding that the victim was subsequently evacuated by air transportation to Bagram Air Field for treatment, and expired at some point after departing FOB Salerno.

Our convoy proceeded from FOB Chapman to FOB Salerno to execute several parts of the convoy plan and to submit the damaged Humvee for repair. A brief stop was made at the accident scene to take photos. FOB Salerno repaired the Humvee, replacing various damaged components to both doors and windows on the passenger side of the vehicle. The convoy departed FOB Salerno, stopped by FOB Chapman to recover several personnel and vehicles and returned to Camp Clark at approximately 1700 local time.

Our vehicle was (2)Hand (1)(2)(3), (b)(was my gunner and CDR)(3), (b)(was the TC. We were showing the new group rippin in the (2)High where we pick up the Chaplins, Postal and Finance to provide services at Camp Clark along with the route to Salerno as part of the turnover. We briefed at 0930 and Sp'd at approximately 1000. At the beginning of the trip everything was going very smoothly. There was a fair amount of traffic but it was moving and there were no traffic jams or stopped traffic. We had gone through down town Khowst without incident and had just past Chapman when we came up on some vehicles that had pulled over for us to pass. On the left travelling opposite our direction were two cars and on the right going the same direction was a tractor pulling a heavy duty metal trailer. The tractor had not pulled over very far and I slowed and was considering stopping. I asked the Gunner and TC if I had enough room and I was told that I did. I continued slowly forward and had the front of the vehicle through the space between vehicles and had just started to accelerate when I heard the Gunner and TC both make noises indicating I was too close. I took my foot off the gas and did not have time to hit the brakes when I hit the trailer with the front right armored window of the humvee. Other than hearing a loud noise, I could not see what happened. The TC window of the humvee came off on impact and the right rear window was partly bent back. The damage to the left rear of the trailer was minimal with some metal on the corner bent but not severely. I called the convoy to a halt and I continued past the tractor to pull forward security. the tractor on the shoulder of the road. He landed on his back, parallel to the road, and seemed to be having convulsions as I could see his legs and arms twitching. The child in the trailer appeared unhurt and dismounted it, going to the (b)(3), (b)(6) driver, looking at him, then taking back off us. - These bolts are not designed to for impact by a sheer force.
- Bolts are not high grade/ high quality. They are a common replacement item on the vehicle.
- FRAG 5 kit is designed to protect vehicle occupants from a force perpendicular to the surface of the door.
- At a rate of march of 10 – 15 mph or less, a side impact creating a shear force would easily cause the front window kit to detach (e.g. FRAG 5 window hitting the edge of the trailer). The detachment of the front window would likely cause the rear window to detach or suffer some damage also.

The medevac was sent to (b)(2)High (b)(2)High to relay to (b)(2)High LT(b)(3), (b)(6) came back to each vehicle to appraise all of the situation and ask if there was any other medical personnel in the convoy. I advised him I was a National Registry Emergency Medical Technician Intermediate (NREMT-I). LT(b)(3), (b)(6) requested that I report to the scene to assist with patient care. I arrived on scene to find one patient lying on the ground, the interpreter from our convoy was attempting to restrain the patient in order to prevent further injury. One Army medic from the lead vehicle was attempting to treat the patient, who was very combative. Due to a head injury, blood was noted coming from his right ear. I asked the medic how long it would take for a medevac to arrive on scene. He was unsure, I then asked what was our other option, and he advised that FOB Chapman was close. It was my decision to transport the patient there. The KPF commander on scene radioed back to his compound requesting an LTV to the scene. Once on scene the patient was placed on a litter and loaded in the back of the LTV. I advised our interpreter to accompany the patient, KPF commander, and the patient's nephew back to FOB Chapman and we would meet him there. After arriving at FOB Chapman I was met by our interpreter, and I requested that he show me where the patient was located. I was escorted to the clinic where the patient was being treated by a Physician Assistant and being prepared for transport to FOB Salerno, patient was on high flow O2 15 liter non-rebreather mask. Patient was placed in back of an ambulance and departed the clinic for FOB Salerno.

On 07 March 2008 I was part of a five (5) vehicle convoy from Camp Clark enroute to FOB Salerno. The order of march was (b)(2)High an LMTV, (b)(2)High I was the driver of (b)(2)High call sign (b)(3), (b)(6). At approximately 1045L, we were 150m past PRT Chapman (b)(2)High driven by CDR(3), (b)(reported that they had had a collision with a local national tractor that was towing a trailer, all vehicles came to a halt and established a security perimeter. Once everyone was stopped, (b)(2)High reported that there was an injury to a local national (it was unknown if he was the driver of the tractor, passenger or a pedestrian). From my position I could see the injured man convulsing on the ground to the right of the tractor. Members from the lead vehicles dismounted and started to assess the injured man and begin treatment. LTb(3), (b)(6)the convoy commander, dismounted (2)Hi along with our interpreter and moved forward to assess the situation. (b)(2)High, along with LT(b)(2)High began the process of initiating a medevac. The medevac was sent to (b)(2)High to relay to (b)(2)High LT(3), (b)(6) came back to my vehicle to appraise us of the situation and asked if we had any medical personnel with us. I replied that DCCS(3), (b)(6)the TC of (b)(2)Hi was a certified EMT. LTb(3), (b)(6)told me to relay to DCCS(3), (b)(6)that he was needed to assist with the injured man. DCCS(3), (b)(6)dismounted (2)Higand went to assist as requested. KPF from PRT Chapman showed up on the scene to assist with security and to find out what had happened. At this time it was decided that rather than wait for a MEDEVAC to arrive at that location, we would request that the MEDEVAC pick up location be changed to the PRT. The KPF commander radioed back to his compound and an LTV was sent to our location. Once the LTV was on station, the injured man was placed on a litter and then he and the litter was placed in the back of the LTV. Our interpreter accompanied the injured man and the KPF commander back to PRT Chapman. Once the injured man was enroute to the PRT, all the vehicles of our convoy turned around and headed to the PRT. Once we arrived at the PRT, I was able to assess the damage to (2)Hi both of the side windows along the right hand side of the vehicle had been sheared from the doors. (I later learned that it was only the front right hand window that was sheared from the initial impact and that the rear window was bent. Due to it being bent the vehicle was unable to negotiate the gates into the PRT and it was sheared at that time.) Rather than put members of our convoy in danger by driving a vehicle with compromised armor, it was decided that we would tow (2)Hi using a tow bar with (2)Higas the towing vehicle. The trailer from (2)Hiwas detached and IT2(3), (b)(and CPT)(3), (b)(6)we left at PRT Chapman with the understanding that we would return for them in the afternoon. With that decided, the convoy departed PRT Chapman enroute to FOB Salerno in the following order of march: (2)HiLMTV, (b)(2)High in the rear. Once we arrived at FOB Salerno (approximately 1300L) we dropped two (2) Corps of Engineers off and continued down to the maintenance area to see what could be done to repair (2)Hi. The maintenance personnel said that they would be able to replace the damaged doors and to return at 1530L to check on the status. At 1500L, I went with IT2(3), (b)(6)to check on the status of the repairs. When we arrived the repairs were almost complete. At 1520L the repairs were complete, so we took (2)Hi back to the staging area to regroup with all the elements that were returning to Camp Clark via PRT Chapman. After the convoy brief we headed back to Camp Clark after stopping at PRT Chapman to pick up CPT(3), (b)(6)and IT2(3), (b)(6)with no further incident.

On March 7, 2008 around 1030hrs local time, while on a convoy to FOB Salerno for the (b)(2)High at approximately 75 meter passed the entrance to PRT Chapman in Khost, an accident between a US Up Armored HWMMV (UAH) and a local national's tractor and his trailer took place. I was the second vehicle in the convoy and the first vehicle after the vehicle involved. Approximately 75 meters passed the entrance to PRT Chapman the first vehicle in the convoy, driven by Navy CDR)(3), (b)(TC was Navy CDR)(3), (b)(6 and Gunner was PO2)(3), (b)(t, got involved in an accident with a parked local national's tractor and his trailer. The US vehicle stroke the tractor's trailer from the back moving it more to the right side of the road. A local national (LN) that was working on his tractor, and a boy apparently his son was sitting on the trailer when the US vehicle ran on the trailer's back while making his way through. Another two vehicles were staggering on the other side of the road (Left side) but it look to me that there was quite enough space to go through. When the US vehicle stroke the tractor's trailer I saw the boy moved to the other corner om the one he was sitting. When I saw the boy right before the accident he was sitting on between the left back corner and the center of the trailer and after the accident I saw him sitting on the right front corner of the trailer. At this time I told my gunner to wave the other vehicles through so we can cleared the area and can assist the injured LN. I paid close attention to the LN and saw him lying on the ground and twitching. Immediately I called the convoy commander Navy Lieutenant (b)(3), (b)(6) to inform him that the LN was injured and apparently was a bad injured from my stand point of view. I called once again advising that the LN was injured and told my crew that I was going out to help him when Lieutenant(b)(3), (b)(6 tried to open my door. When I opened the door he ask me for the Aid bag and told me that he was going to call for MEDEVAC. I made my way through him and got the aid bag from my vehicle and started running towards the LN. When I got to the casualty the garrison interpreter was there and helped me assess the casualty while trying to keep the boy calmed at the same time, since he was crying and screaming. The LN was still on the ground grouning and trying to move arround and I told the interpreter to tell him that he should not move and that I was going to help him. While I was applying first aid to the LN other convoy members picked up the door of the UAH from the ground and placed it on my vehicle. Navy Senior Chief(b)(3), (b)(6 arrived to the area and helped me stabilize the LN. I kept talking to the LN through the interpreter to find where other places he was hurt. The LN was bleeding from the mouth and from the left ear. His hand were tilted inside but not broken and he still twitching by moments. I also asked the boy if he was hurt but he did not answer just kept crying and screaming and he told the interpreter if he could get his uncle to the area. I asked the interpreter the whereabouts of the uncle and the child reply that he was at the Bazaar. I tried to stabilized the LN and told the interpreter to keep his head above the chest because of the injury. Lieutenant(b)(3), (b)(6 came to me and told me that we needed to take the LN into PRT Chapman because the MEDEVAC was not going to be able to arrived at that location. I saw some KPF soldiers that arrived to the scene to help us out with the population and the security and someone asked one of the KPF soldiers to get one of their LTVs to put the LN and the boy on it and take them to PRT Chapman. SGT(b)(3), (b)(6 who was driving the LMTV behind us, got the litter that was on the back of my vehicle and we placed the LN on it and put him on the back of a KPF's LTV. With the assistance of the KPF and the garrison's interpreter they moved the casualty and the boy into PRT Chapman.
