MEMORANDUM FOR Claimant

SUBJECT: Claim Denial

1. This is in response to your claim against the United States Government. Your claim has been reviewed under the Foreign Claims Act, 10 U.S.C. 2734, as implemented by Army Regulation 27-20, Chapter 10. I regret to inform you that your claim has been denied.
2. Your claim has been denied for the following reasons:

 - c. The evidence shows that the damage was caused during combat.
 - d. The evidence shows that the damage was caused by your own negligence or wrongdoing.
 - e. The evidence shows that your claim was fraudulent.

3. If this is the first time your claim has been viewed by this office, you may submit an appeal. This office must receive the appeal no later than 30 days after receipt of this message. The appeal must also contain additional evidence proving your claim. If the appeal is sent after 30 days has passed, or does not provide additional evidence, then the appeal will be denied.

MEMORANDUM FOR RECORD

SUBJECT: Foreign Claims Investigation, (b)(6)

1. **Identifying Data**

- a. Claimant: (b)(6)
- b. Date, time and place of incident: 27 Feb 07, Baqubah, Iraq.
- c. Amount of claim / date request filed: \$225,100.00 / 10 Apr 07.
- d. Description of claim: Property damage.

2. **Jurisdiction**. This request is presented for consideration under the provisions of the Foreign Claims Act, 10 U.S.C. Section 2734, as implemented by Chapter 4, Air Force Instruction 51-501. This claim was filed in a timely manner.

3. **Facts**. The claimant alleges on 27 Feb 07, CF conducted an air strike that damaged his flour factory and killed his two guards. The claimant also alleges that CF along with IA entered and searched his house after the incident and stole about \$4,600 cash and about \$1,150 worth of jewelry from the claimant's wife. The claimant also alleges two AK-47s used for protecting his family and building were confiscated.

4. **Legal Analysis**. Upon review of the allegations against CF, it was found that CF were receiving a high volume of SAF from this building. SIGACTS show CF troops in contact (TIC) (b)(2)High building. There is no evidence of CF searching the claimant's house after the TIC or confiscating any money, jewelry or weapons.

5. **Damages**. The claimant's flour factory was heavily damaged from the two 500lb GBUs. The structure was also heavily damaged from bullet holes resulting in CF returning fire.

6. **Recommendation**. That the claim be denied under the FCA due to the combat exclusion.

And they heard our cry out and the cry of the children's and after that I came down from my hose as the requested.

And then they separate the women and children from me and my cousin and after that they asked me to identify the gourd bodies inside the company and they are

they died because the air strike and the random shooting when the Iraqi Army entered the company and they start to shoot fire randomly and after that one of the American soldiers gave me a piece when you break it .it dose give light and he gave me four of them after that I went to my family .and the Iraqi Army start to insulate me and abuse me and when I showed them the company ID that am working in it .then the American solider told me to go in my own and after that iv been surprised by the rubbery of my property and money in my house in the raid that did happened .and its estimated by 4,600 dollar and my wife jewelry's 1,500,000 Iraqi dinners And then one of soldiers told me that there were insurgents in the company and my answer to him was: that this is wrong because there in no any personals or bodies in the company except the gourds bodies.

And then after that one of the American soldiers took a big bag and starts to collect some kind of small rockets in the company hall and put them in the bag and took it with him

And then my children's and my family start crying harder and harder because of the miserable situation that we were in which was very hard situation.

And then one of the Iraqi army soldiers start threaten me by killing me with out any reason then he told me after that to line up all the family in one place me and my cousin ,his wife ,his sister in law ,my wife and our children's

.and at 7:30 PM of the same day I went outside the area according to what I asked the American soldiers

So me and my family be safe and I broke those pieces and one of them gave red and the other one green light .i went to one of the company employees from the company and I spent the night in his house with my family .and in the morning of the next day I went to company and I saw the destruction in the company without any reasons to be mentioned .and I didn't see any bodies except the bodies of our company gourds .and we used to have just two AK-47 rifles to protect the company and one of the American soldiers examine the weapons by smell the and he found that it didn't shot . And the American soldier confiscate on them

Sub /damages estimation

We took a look on the (b)(6) to estimate the damages on the company as a result from the air strike by the American air plains that happened mistakenly and we found out that the building general material damages including the building and equipments as follows:

1-constracture damages.

The company consists from (b)(6) stories including the basement and the damages in the building are as follows:

The basement / the damages is 30%

The floor / the damages is 40%

The (b)(6) floor / the damages is 60%

The (b)(6) floor / the damages is 70%

The floor / the damages is 90%

The above mentioned percentages is approximated according to the damages in the doors and windows also the glass and some of the building parts fall down and other parts crackdown and these damages resulted from the American air strike .

2- The material damages.

That it's happened to the machines and some parts of the building fall on some of the machines and the damages of these equipments according to the building damages plus there is damage in the two vehicles also the destruction of the falling coverage and the grain and the vehicle garage.

3- The company will stop from receiving the grains for six months to build and fix the equipments.

We would like in the beginning, to define the type of work of our company (b)(6) in Diyala province. Baqubah in AL MUA'ALMEIN Q 1st industrial area and belongs to

(b)(6)

And the ownership of the company is from the land and the buildings and the machines and trucks to transport and apartments for the technical staff.

(b)(6)

The company consists of the commissioner manager, a financial manager, a storing manager, a company mailman, a sales manager and the technical staff (ten person's) and cleaning workers and grand receiving workers and the loaders (total 30 person's) so the total will be approximately 50 employees.

And the company benefits ten dollars for each ton of grains from the ministry of trade and the silage is for the company and the productive capacity is 100 tons from grain in a 24 hour period and to receive grain from 1,500 tons to 2,500 tons per month. This does depend on the receiving of the other companies of its share and in the last months our company received 2800 tons per month because the companies in KHAN BANY SAAD stopped working and processing grains from the Ministry.

On 27 February, 2007 at 3:30 PM our company was damaged from a Coalition Forces Air Strike which resulted in human, financial and emotional damages and also resulted in the killing of two of our company guards. The following is a full report on the damages.

- 1- Steel facilities structures. The purpose is to protect the (b)(6) from rain. It has been destroyed. total cost is: (\$19,000.- dollars)

- 2- Damages in the all (b)(6) stories of our Primary Offices and Factory building. The damages totally destroyed the filter room completely in the last store and other civil structures damaged from the fire caused by the air strike is estimated at (\$21,000.- dollars)
- 3- The company also lost two trucks. Their estimated value by (\$4,300.- dollars)
- 4- The (b)(6) floor consists of our (b)(6) and damaged to their systems, its transmission, its electrical motors and all the glass tubes have been damaged. Also a part of the electric power board has also been damaged. It is estimated at: (\$10,000.- dollars)
- 5- An 8 ton steel (b)(6) container has been badly damaged. Repairs are estimated at: (\$3,500.- dollars)
- 6- Two (b)(6) belt transfer systems (Boxed-Augur type transferring machinery) has been completely destroyed. Estimated replacement costs is: (\$1,600.- dollars)
- 7- (b)(6) floor consists of the same type of system above in #6, (Boxed-Augur type transferring machinery) and glass tubes. All the glass tubes have been displaced and destroyed in all the electrical motors. Estimated at: (\$7,800.- dollars)
- 8- Flour elevators (two) have been damaged by shrapnel pieces and burned the moving belts. Estimated at: (\$1,500.- dollars)
- 9- (b)(6) elevators (two) suffered the same damage. Estimated at: (\$1,500.- dollars)
- 10- (b)(6) consists of a "saffater", or a filter system, (three of them) which is a machine that separates the flour from the silage and consists of electrical motors (three each) set inside a wood frames (270 frames). Each wood frame has some silk material in it to isolate the flour from the impurities in the grain. The floor was completely destroyed also with the electrical board of the whole floor estimated at: (\$30,000.- dollars)
- 11- The (b)(6) floor consists of air tubes with air locks with (b)(6) It has been hit by shrapnel with damages to the electrical board housing. Estimated at: (\$4,000.- dollars)
- 12- The (b)(6) moisturizer floor had damages in the (b)(6) moisturizer device and it needed to be replaced and also destroying of brain (wet grain transferring machine) with the electrical motors and destroyed the powder room. Estimated cost: (\$8,000.- dollars)

13- Because of the air strike and shrapnel and the fire in (b)(6)
most of the lighting system with its wiring network with the electrical
cables to run the electrical motors were badly damaged. Estimated
cost: (\$4,000.- dollars)

14- The company needs time of between four to six months to be able
to work again and the specialized technical crew to rebuild our
factory. They want (\$30,000. - dollars) for repairs for the company.

15- The company earns almost nearly (\$15,000.- dollars) per month
and the cash flow will have to stop being earned for at least the next
five months, so our total costs as a loss will be, at a severe minimum
estimate, at least: (\$75,000.- dollars)

16- All the glass windows of the company were destroyed, along with
the steel doors. All the walls will have to be repainted again as well as
some parts of the company, including the building and several
machines. This is estimated at: (\$3,000.- dollars)

Dear Gentlemen, right now I can not rebuild the company from my
own pocket because I do not have this amount of money and it is the
only source of earning a living for me and my family is the company.

I hope from you, to study my request and to give me the mantel
and financial support to me and my (b)(6) family. And I ask only for
assistance so I can run the company again and bring back our
company staff so that they are employed once again. They are now
with out jobs. Also this will allow our company to once again supply
the flour to the whole province once again.

Sir, my request is to get the 1st payment (25%) from the total
amount which is (\$225,100.- dollars) until I can get the approvals to
issue the whole amount and complete the necessary paper work and
rebuild my factory once again.
