I was one of many people who clapped to US army when they entered Kirkuk city. I was thinking of happy life after Saddam's fall on April 9th 2003. I heard a lot about US society, the democracy, human rights, and love of life that they have and fight for. I used to hear a famous sentence from US citizens "free man in free country" which is United States of America's favorite sentence.

I was eager to be a member in this operation, so I got in touch with US army to offer my help at the first chance I got.

I used to talk to my family about US troops and their aims of being in Iraq. What they did to release Iraq from Saddam's rule. I used to tell my kids that US troops are our friends they came to help Iraqi people to start new life new happy days, away from Saddam's injustice rule. My wife and kids were a big hope for me in my life and daily career. My 6 years old daughter (b)(6) was one of the kids who threw US troops with flowers and singing happy songs for them, whenever she saw them coming by our neighborhood.

But, I never thought (b)(6) is going to be shot by US troops at the same neighborhood where (b)(6) used to wave and sing for them. I just want to know. Where are the US justices, when the bad apples of US troops shot my little child in cold blood? What threats she made? One single shot, one second (b)(6) was past away my life was over, white turned to black, and happy dream to a nightmare. It was One shot and one word SORRY!!!!

It happened when I was driving my family home from my father's home at (b)(6) the (b)(6) neighborhood where my house is located I was driving, my wife was beside me and my kids were sitting in the back seats. It was 8.30 pm (b)(6) was talking to her mother of what she did at the school with her friends. We arrived at the neighborhood garden by the NOC building at the turn which leads to our house; suddenly I heard a shot came in through the front wind shield of my car. I stopped the car immediately and turned on the inside lights. I didn't know what was happening. Suddenly US soldiers showed up from the corner aiming their guns toward us and they said sorry, at that time I heard my wife screaming and saying (b)(6) at that time I knew (b)(6) was shot. I didn't know what to do. Only drive to the hospital to save my little child, but it was too late she was bleeding in head. I still don't understand why that happened. I was not drive in speed, it wasn't at curfew time. I was in my neighborhood which supposed to be safe neighborhood for us and US troops nothing happened there before, there was not any US convoy or any threats and why did they shoot to kill only one shot in a head of my poor little girl. Is sorry enough? Where is US justice and democracy? What were happening if (b)(6) were a US CITIZEN? Is (b)(6) going to be the last innocent victim of US bad apple troops? Only the justice we seek.

We were at my father's house for a visit. It was at sunset when I asked my little family to go back home.

We rode to my private car (b)(6) (b)(6) model).

My wife was sitting in the front seat beside me. The kids were sitting in back seats.

We took off towards our house which is at the same neighborhood; it takes a few minutes of driving to be at home. I was not drive fast , when we arrived at the entrance of (b)(6) hall garden I turned my car to the left towards of my house, I was driving too slow, because I knew there were barb wires and hitch hocks, so there is no way to be driving fast. (There is no US troops in the area only IA). Suddenly I heard a fire shot coming from the dark corner and there was a hole in front window and back window was blown. At that time we saw many flash lights approaching toward my car. when I saw the lights I saw US troops so, I turned the interior light of the car on to be identified by them (we are a family) they were still pointing their guns to us while I was shouting in English ,saying I have kids in the car, we are civilian. The solider were wearing night visions so there is no chance not seeing us. At that time I heard my wife screaming & saying (b)(6) (b)(6) She was lying in the seat on her face & bleeding from head, so I yelled at the soldiers (u killed my little baby) the only word that I heard from them was SORRY????

I stepped out of my car to check on hear then I hold her she was unconscious & bleeding, my wife was screaming the only thing that I was thinking of at that moment is to save her life by taken her to the hospital. The US soldiers didn't move still they didn't even trying to help. finally I was a (b)(6) Hospital ,she was still bleeding but alive ,after 20 minutes the US soldiers showed up & they offered to take her to the Airbase but it was too late she was already dead ,the soldiers disappeared at once .

After one day they sent an Iraqi officer from ESU asking permission from us for the US soldiers to come to my house to apologize & to negotiate. I did not give them the permission, because my family and the whole people in the neighborhood were angry and in shock and still. The more disappointed thing is the US troops story; they didn't say the truth of what really happened in investigation. The bad apples of the US troops who committed the murder, said they warned me more than one time and they shoot to the hood and the radiator of the car. Lies and lies yes, which is what they said.

I have the evidences of the truth of my words that they can not deny about it. They have the photos of my car, there is only one shot went through the front wind shield of my car which killed my little girl. Please see and check the attached photos of the car to be sure that they were shooting to kill not for warning. We all ask who is going to be the next victim. Are we going to wait till another innocent human get killed and

hear SORRY again? (For your information (b)(6) is the victim number 7 during the last month get killed by US soldiers & we hear the same word Sorry!! Sorry!!) I am as a father of (b)(6) years old girl who killed by US troops asking each individual of USA citizen to support the innocent victims and to put the bad apples of US troops to the court and send them home. We ask the US court to say its word. We want to see the justice of USA. What the situation was look like if (b)(6) were a USA citizen? So as a father of (b)(6) I ask the USA government to get my little girl's rights according to USA constitution and human rights. We always hear & see the US president & its government on TV saying that the (b)(6) people are our friends & allies & how much our (b)(6) neighborhoods save for US troops. Are we still friends??? I would ask (b)(6) this question if she was alive .

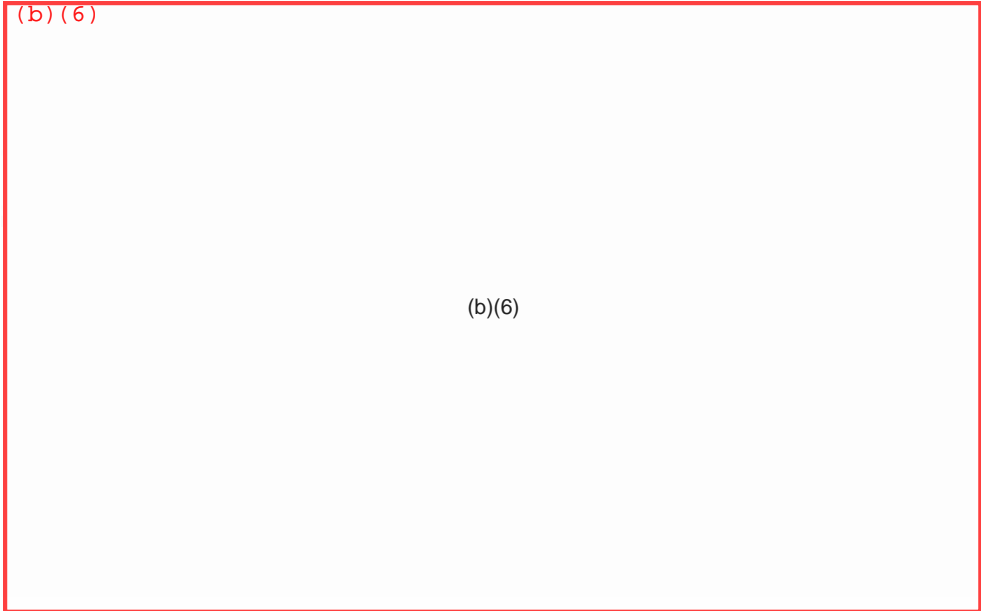
