MEMORANDUM FOR Commanding Officer 3rd BCT, 25th Infantry Division, FOB Warrior, Kirkuk Iraq

SUBJECT: Request for money from the 2-27 CERP Commander's Condolence Fund

1. The purpose of this memorandum is to request a Condolence Payment be made to (b)(6) (b)(6) in order to express sympathy for the death of his son (b)(6) (b)(6)

2. Description of the Event: At 010900JUL07 (b)(2)(High) reported an EOF while traveling West on route (b)(2)(High) (b)(2)(High) resulting in 2x LN KIA and 1x LN WIA. (b)(6) (b)(6), a taxi driver, was transporting five local nationals in a (b)(6) sedan East bound on route (b)(2)(High). The driver bypassed six local nation vehicles that were stopped on the South side of the road and proceeded toward the (b)(2)(High) patrol. SPC (b)(3)(b) the gunner of the lead vehicle utilized hand and arm signals to alert the civilian driver and at (b)(2)(High) fired a flare with no effects. At (b)(2)(High) the gunner fired a warning burst of 3x rounds of (b)(2)(High) impacting to the North side of the road. The vehicle continued and showed no sign of slowing or changing course. At (b)(2)(High) meters, the gunner fired 10x rounds of (b)(2)(High) to disable the vehicle resulting in 2x LN KIA and 1x LN WIA. B26 cleared the vehicle with NSTR and began administering aid to the casualties. The vehicle subsequently caught fire and quickly became engulfed in flames. The casualties were transported to PB Baker. At 0957 (b)(2)(High) departed PB Baker with (b)(6) (b)(6) Hilal suffering from a GSW to the abdomen and fragmentation wounds to the legs. The casualty was MEDEVAC to FOB Warrior for further treatment

MEMORANDUM OF OPINION

SUBJECT: Claim of (b)(6) (b)(6), 07-I14-T285

1. Claimants name and address: (b)(6) (b)(6) (b)(2)High Iraq.
2. Incident date and place the incident occurred giving rise to the claim: Incident occurred on 1 July 2007 in (b)(2)High Iraq.
3. Amount of claim and filing date: Claimant filed a claim in the amount of \$2,500.00 on 1 July 2007.
4. Chapter the claim was considered under and a brief description of the incident or of the issues raised by the claimant on reconsideration: Foreign Claims Act and Chapter 10, AR 27-20; claim filed for death of a local national.
5. Facts:
 - a. (b)(6) (b)(6) claims that on 1 July 2007, he was involved in an EOF with 2-27 IN, and as a result his son (b)(6) (b)(6) was killed.
 - b. There was a story board included in the submitted claim.
 - c. The incident was able to be verified by the unit responsible.
6. Opinion:
 - a. In order to form a basis for a claim under the FCA, the incident has to occur outside of the United States and be from either non-combat activities of the U.S. Armed Forces or by negligent or wrongful acts of military members or civilian employees of the Armed Forces.
