5.	Facts:						
	a. (b)(6) claims that on 22 July 2007, she was involved in an EOF incident with 2-27IN, and as a result her husband was killed.						
	b. There was a story board included in the submitted claim.						
	c. The incident was able to be verified by the unit responsible.						

6. Opinion:

a. In order to form a basis for a claim under the FCA, the incident has to occur outside of the United States and be from either non-combat activities of the U.S. Armed Forces or by negligent or wrongful acts of military members or civilian employees of the Armed Forces. 4
