Description of the Event: At 112306AUG07, Renegade 26 reported one MAM conducting suspicious activity consistent with an IED emplacement IVO (b)(2) High As the SWT arrived on station the MAM fled to the West and attempted to conceal himself under a blanket. At 2310, R26 requested IED activity IVO location. NF TOC reported that there had been 2x IEDs within (b)(2)High of the site in the last thirty days and that the ground was clear of CF. At 2319, R26 reported engaging the MAM with 100 rounds of (2)High and 30 rounds of (2)High lifting the target. At 0034, Comanche 36, the McHenry QRF responded and conducted SSE with negative contact with IED material and negative (b)(2)High of the KIA.
