a. (b)(6) claims that on 6 August 2007, his wife was killed as a result of an EOF by 2-27 IN.						
b. There was a story board and a photograph included in the submitted claim.

a. In order to form a basis for a claim under the FCA, the incident has to occur outside of the United States and be from either non-combat activities of the U.S. Armed Forces or by negligent or wrongful

acts of military members or civilian employees of the Armed Forces.
