My child affected after short time of the explosion, and when the U.S. Army was fire in random due to one of wheels is affected and this show that my child is affected result the random firing.

a- After I hear the explosion, and because of the classroom contains on several of windows and for protecting of the students, I asked from them leaving of the classroom and go to the walkways.

b- The child is affected after the random firing and not during the explosion because she was in the classroom during happen the explosion.

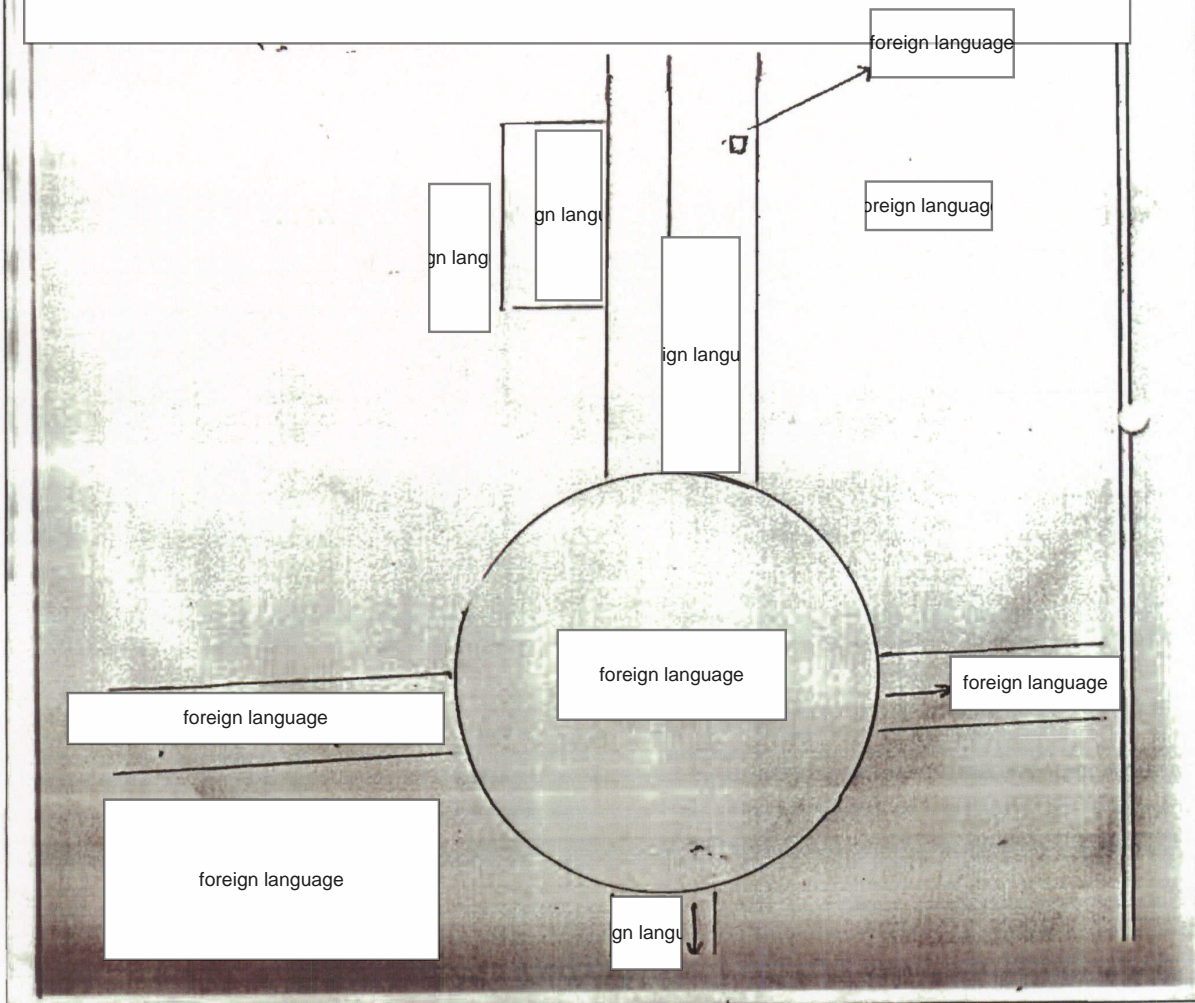
