You have submitted a claim seeking compensation for the loss of your loved one. I have thoroughly reviewed your claim pursuant to the Foreign Claims Act (FCA), Title 10, United States Code §2734, Army Regulation 27-20, and Department of the Army Pamphlet 27-162 Claims Procedures.

Allow me to express my sympathy for the loss of your loved one from events occurring on July 8, 2007. However, in accordance with the cited references and our investigation of the operational records concerning your claim, your claim is not compensable. After a search of records of the date in question, the evidence provided showed that damages were the result of combat operations. Damages directly or indirectly related to combat operations are not compensable. Further, there is insufficient evidence that the damage was caused by U.S. forces. Accordingly, your claim is denied.

If you are dissatisfied by this action, you may request reconsideration of the decision in accordance with AR 27-20. Any such request must be based on new or additional evidence and should be forwarded to this office. While there is no prescribed format for such a request, it must describe the legal and/or factual basis for relief. Any request for reconsideration should be made in writing within 30 days of your receipt of this letter. Thank you for your kind attention.

MEMORANDUM OF OPINION

SUBJECT: Action on Claim of (b)(6) Claim # 08-IJ6-T052

1. Claimant's Name and Address (b)(6) Baghdad (b)(2)High  
(b)(2)High

2. Date and Place the Incident Occurred Giving Rise to the Claim: (b)(2)High  
Area, Baghdad, 15 July 2007.

3. Amount of Claim and the Date it was Filed: Claimant seeks compensation in the amount of \$40,000 for the deaths of her (b)(2)High The claimant completed the Claims Form on 25 October 2007. The 1-4 BCT BOL1 received the claim on 10 April 2008.

4. Chapter(s) under Which the Claim Was Considered, and a Brief Description of the Incident or of the Issues Raised by the Claimant Upon Reconsideration: Foreign Claims Act and Chapter 10, AR 27-10: Claim filed seeking compensation for death.

5. Facts: Claimant states that during fighting between CF and the Mahdi Army on 25 October 2007, her (b)(6) sons were killed in an airstrike by the U.S. Air Force. No 15-6 was conducted into this incident and no SIGACTs were recorded. TIGRnet is silent about this purported incident.

6. Analysis:

a. In order to have a cognizable basis for a claim under the Foreign Claims Act, the claimant must demonstrate that the incident occurred outside of the United States and that the damage was caused by noncombatant activities of the U.S. Armed Forces or by the negligent or wrongful acts of military members or civilian employees of the U.S. Armed Forces. Additionally, a settlement authority may pay a claim even if the injury results from a criminal act clearly outside the scope of employment or duties of the military member or civilian employee. See AR 27-20, para. 10-3a.

b. Based upon the claimant's version of the events, her sons were killed in an airstrike by U.S. Forces during a combat action. Moreover, there is insufficient evidence that CF were involved at all in the death of the claimant's sons. Accordingly, as unfortunate as the death of her sons may be, the claimant's claim is not compensable under the Foreign Claims Act.

6. **Recommendation:**
  - a. In order to have a cognizable basis for a claim under the Foreign Claims Act, the claimant must demonstrate that the incident occurred outside of the United States and that the damage was caused by noncombatant activities of the U.S. Armed Forces or by the negligent or wrongful acts of military members or civilian employees of the U.S. Armed Forces. Additionally, a settlement authority may pay a claim even if the injury results from a criminal act clearly outside the scope of employment or duties of the military member or civilian employee. See AR 27-20, para. 10-3a.
  - b. Based upon the claimant's version of the events, her sons were killed in an airstrike by U.S. Forces during a combat action. Accordingly, her claim is not compensable under the Foreign Claims Act.
  - c. Pursuant to paragraph 10-9c, AR 27-20, the undersigned one-member FCC lacks authority to deny this claim, which seeks compensation in the amount of \$40,000.00. I hereby forward

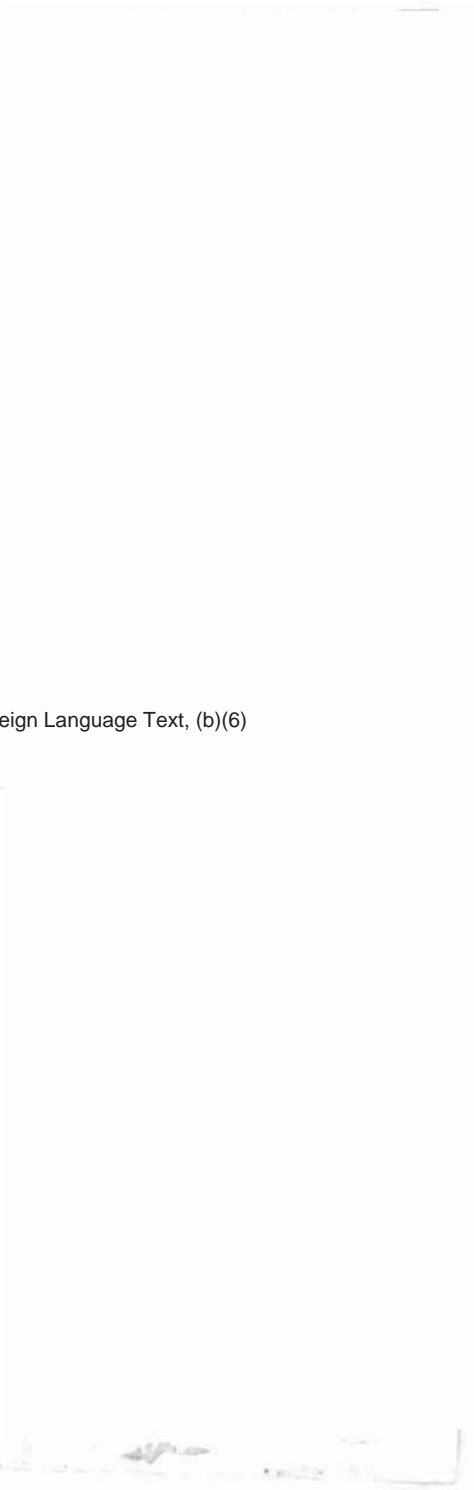
