7. **Recommendation:** For the reasons stated above, this claim must be denied payment under the provisions of the Foreign Claims Act.

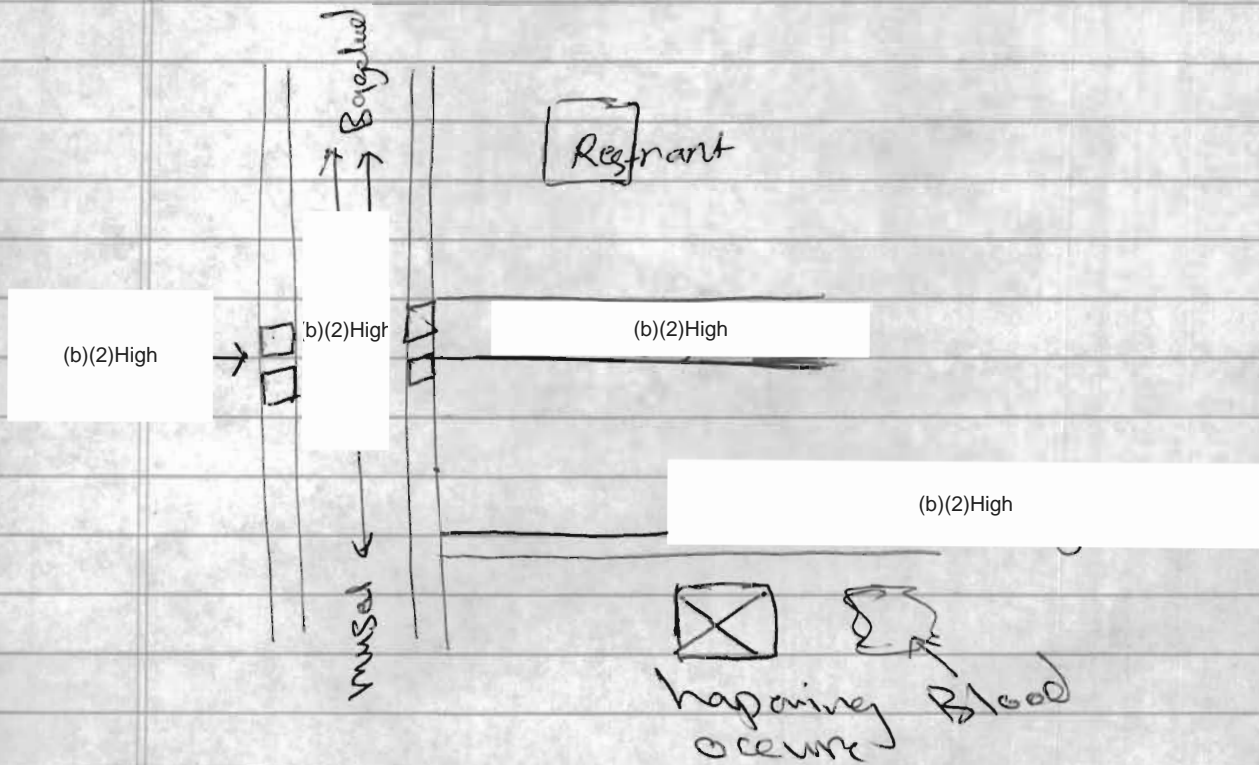

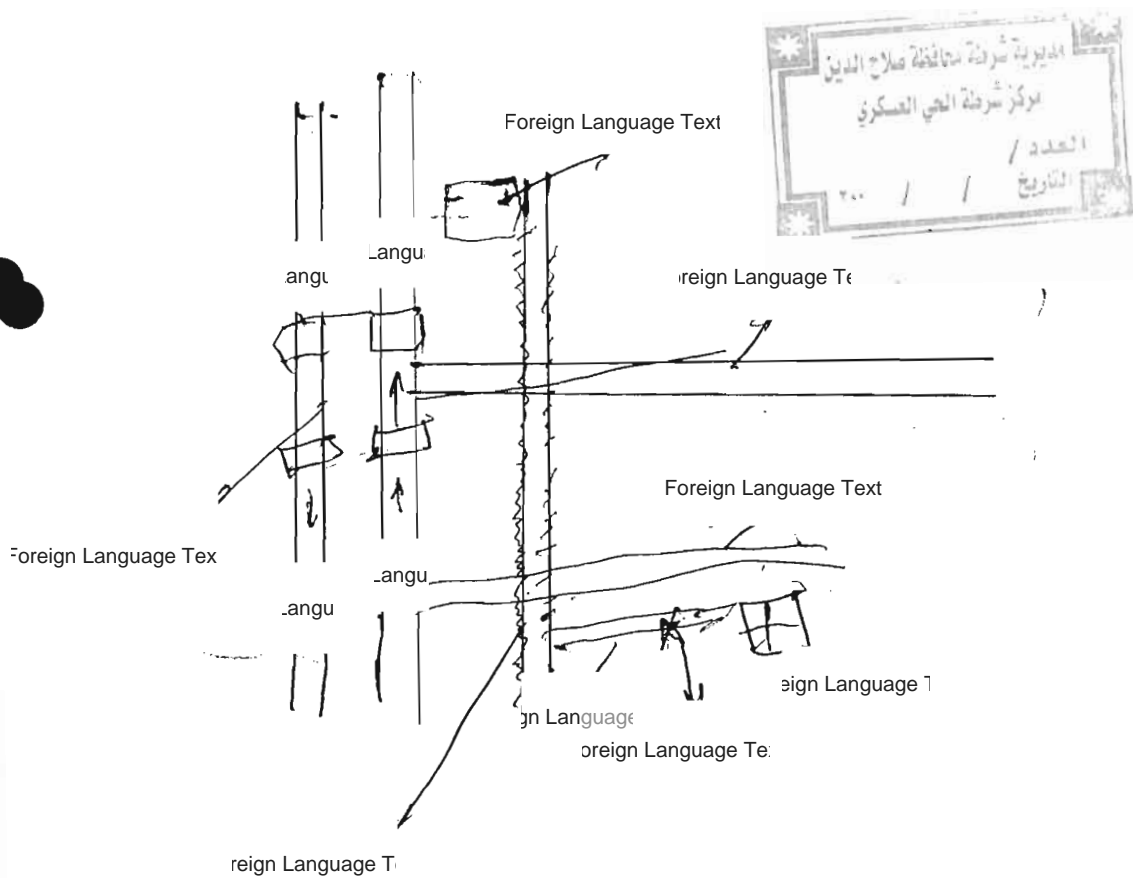
