4. **Jurisdiction:** This claim was made pursuant to the Foreign Claims Act, 10 USC §2734, as implemented by Army Regulation 27-20, chapter 10. Said claim was timely presented in accordance with the statute.
5. **Facts:** Killed by U.S. gunfire.
6. **Opinion:** In accordance with AR 27-20, paragraph 10-3, claims arising directly or indirectly from combat activities of the U.S. Armed Forces are not payable under the provision of the Foreign Claims Act.
7. **Recommendation:** For the reasons stated above, this claim must be denied payment under the provisions of the Foreign Claims Act.

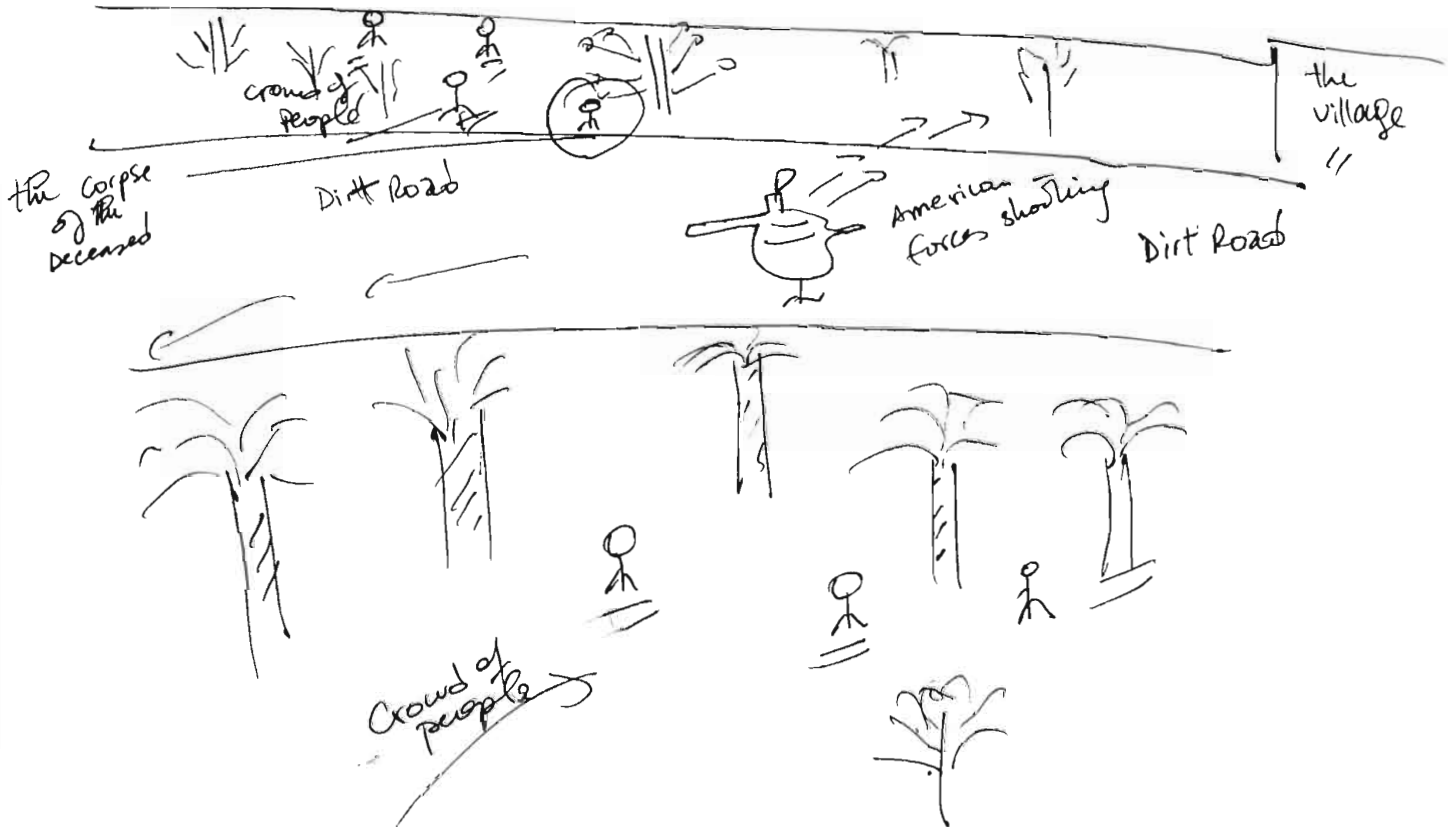

During the inspection we found out the following:

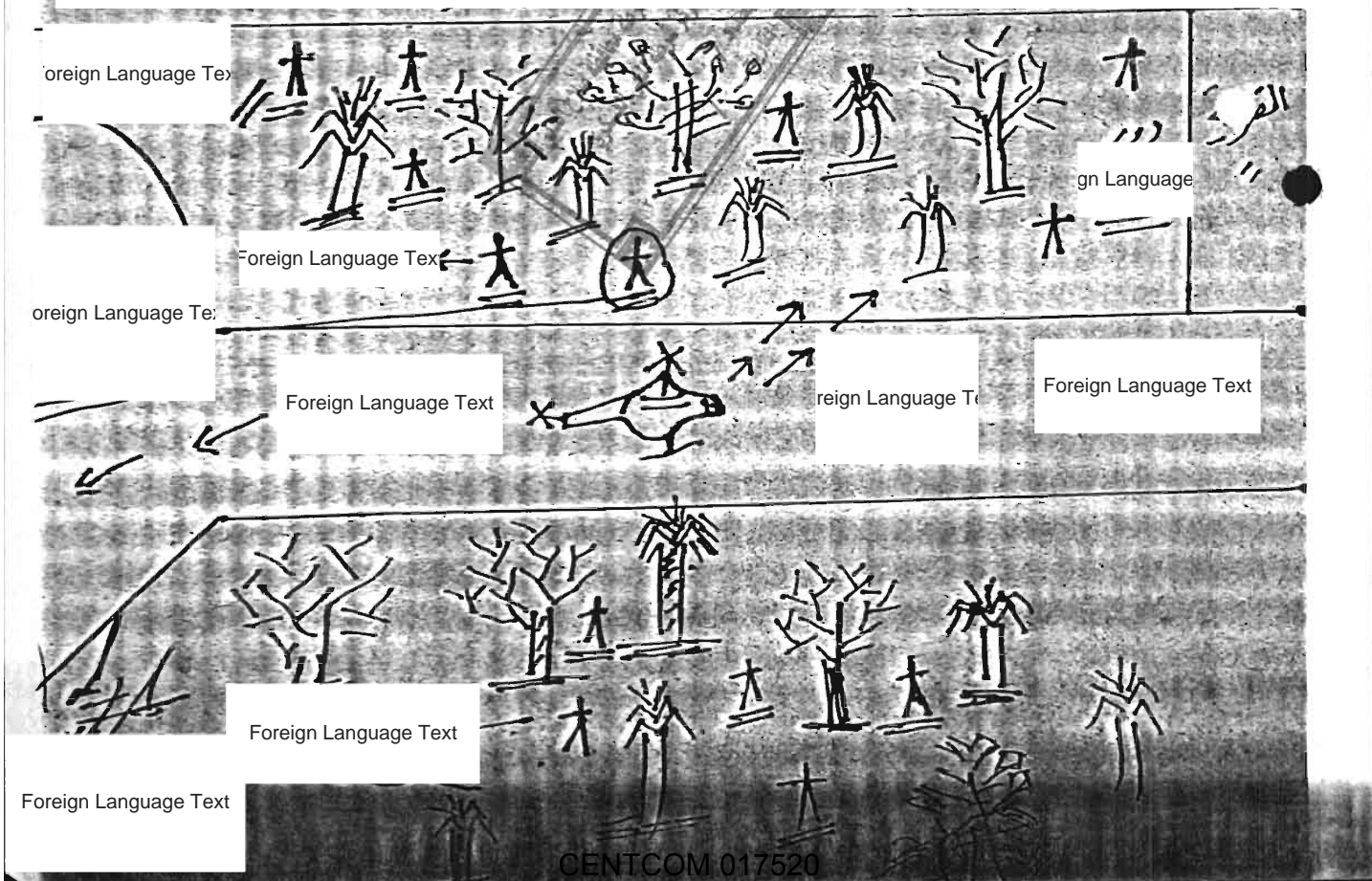
- The incident scene is about (b)(2)High from our police station
