4. DESCRIPTION: On 02 January 2005. (b)(6) sister, a local national, was traveling to the College of Science for Girls. While near Coalition Forces, an IED exploded, and both the Iraqi Police and Coaliton Forces engaged the AIF with gunfire. During the incident, his sister was struck by a stray bullet in the crossfire, and later died.

5. JUSTIFICATION: By making this condolence payment, MNF ensures the family and community recognize the MNFs' sympathy for the unfortunate occurrence. Support will positively influence both the community and local Iraqi leaders.

- 1. (b)(6) submitted claim # 114H for the compensation of his sister that was killed at 1130 am, one morning in the January February 2005 timeframe. During the incident, an IED exploded, and both the Iraqi Police and Coalition Forces returned fire. His sister was struck by a stray bullet in the crossfire, and later died.
- 2. The claim was submitted approximately five months ago with documentation from the hospital, IP, and a witness statement from the driver. The claim was originally denied, due to combat activity.
- 3. We would like to reconsider this claim for a condolence payment, but cannot locate the original claim packet that was submitted. To process the case, the claimant should resubmit the supporting documentation, with a copy of this letter. At that time, we will be able to review the case and make a decision.




