One Iraqi civilian, the driver, was killed by b)(2)High bullet that went through his head.

The local national involved in the incident is dead so no compensation has been granted. Compensation should be granted to the deceased person's family due to the fact that the vehicle was not a confirmed VBIED. No effort has been made to compensate the family because the deceased person's identity is unknown.

D. Determine if there was a threat for VBIED in this particular area. Determine how many times 2-69 CAB patrols have been attacked by VBIED in this current deployment. Provide an intelligence analysis of the current threat to VBIED to the battalion.

There is no history of VBIED attacks on the battalion.

2. You will issue Findings and Recommendations that cover the following areas of inquiry:
  - a. Assess the use of force with respect to the Rules of Engagement and the Law of Armed Conflict.
  - b. Identify all individuals wounded/killed in the EOF. Determine whether wounded local nationals were engaged in hostilities against Coalition Forces at the time of the incident.
  - c. Determine whether local nationals involved in the incident should receive compensation for injuries and/or damages to their vehicle. Describe what efforts the unit has made to pay the killed civilian's family.
  - d. Determine if there was threat for VBIEDs in this particular area. Determine how many times 2-69 CAB patrols or operations in sector have been attacked by VBIEDs in this current deployment. Provide an intelligence analysis of the current threat of VBIEDs to the battalion.
  - e. Identify any other relevant matters that you discover in the course of your investigation.
3. Your legal advisor is CPT (b)(3), (b)(6) 2nd Brigade Operational Law Team, VOIP 772-7052, who will give you an in-brief before you begin your investigation and be available to assist you during the investigation.
4. You may speak with any and all individuals that you believe have information pertinent to your investigation. You will obtain guidance from your legal advisor if in the course of your investigation you determine that completion thereof requires examining the conduct or performance of, or may result in Findings and Recommendations adverse to, a person senior to yourself.

(5) (U) In many EOF engagements, the local national citizens claim that the driver of the vehicle panicked when he was fired upon. That explains most acceleration and erratic driving. The panicked driving is interpreted by Soldiers as a hostile act or display of hostile intent. Most experienced American drivers would probably panic if an armed person were firing at their vehicle.
