3. **Facts.** The claimant alleges on 14 July 2007, CF AWT engaged a target in the Shifta neighborhood. The claimant's son went down to see what was going on. CF AWT engaged again. As a result of the engagement, the claimant's son, (b)(6) was killed.

4. **Legal Analysis.** CF were engaged in combat operations when the claimant's son was killed.

5. **Damages.** The claimant's son was killed.

6. **Recommendation.** That the claim be denied under the FCA due to the combat exclusion.

scare , after more than one hour I discovered that my son has been murder by this mission , then the men in our village come to help our family so they bring him to Ba'quba general hospital ,

At the same day at 9:00 Am the American army come and met with the chief of our tribe (b)(6) they told us that they are so sorry for this unintentional mistake and we are ready to compensate us,

Now am living with my sick husband and small kids with out breadwinner, I don't know what's my or my family guilty to bear all this harm from this mistake.
