The policemen who surrounded the area, they transported their relative before they made raid the homes, they transported the relative before 6 hours then they made by raid one home of civilian (b)(6) because exist the terrorist in this home, but they didn't fined any terrorist in this home, just they found family, and family contains children and women and Gun misused but you know that every body to bear Gun to defend about himself and his family then the telefar police shot randomly until 1.30 at mid night after that they asked of one civilian his name (b)(6) to go with them to his uncle's home, his uncle's name (b)(6) (b)(6) after they took him to his uncle's home, they asked him about the guys at his uncle's and he told them that there is
