Pursuant to Paragraph 2 of the Third Stipulation and Order Regarding Document Processing and Production by the U.S. Department of Defense, Paragraph 3 of the Stipulation and Order Regarding Document Processing and Production by the U.S. Department of State, and Paragraph 3 of the Stipulation and Order Regarding Document Processing and Production by the National Security Division of the U.S. Department of Justice, enclosed please find documents representing the releaseable portions of all outstanding referrals and consultations in this matter, as follows:
