PLAINTIFFS' MOTION FOR SUMMARY JUDGMENT

Pursuant to Rule 56 of the Federal Rules of Civil Procedure, plaintiffs in the above-captioned action respectfully move the Court to enter summary judgment in their favor. In this suit, U.S. plaintiffs challenge the government's violation of their First Amendment and statutory rights by its exclusion of Professor Adam Habib, a prominent South African scholar whom U.S. plaintiffs have invited to speak at upcoming events in the U.S.. There are no genuine issues of material fact in dispute. For the reasons stated in the attached Memorandum in Support of Plaintiffs' Motion for Summary Judgment and in Opposition to Defendants' Motion to Dismiss Complaint, plaintiffs are entitled to judgment as a matter of law.
