- 4. That Plaintiffs shall respond to Defendants' newly filed Motions on or before <u>June</u> 20, 2006.

- 5. That any reply by Defendants to the response of Plaintiffs shall be filed on or before June 27, 2006.
- 6. That oral arguments on Defendants' Motions will be held on Monday, July 10, 2006 @ 9:00 a.m.
