

ORDER


BE IT REMEMBERED on the 6th day of April 2007 the Court reviewed the file in the above-styled cause, specifically the supplemental briefing filed by the parties in response to this Court's Order of March 21, 2007. It has come to the Court's attention that the medical records of the minor Plaintiffs, filed by Defendants as exhibits A-H in support of Defendants' "Reply to Equitable Remedies Sought by Plaintiffs" [filed March 26, 2007], and the medical records of Plaintiffs' parents, filed by Defendants as exhibits 6 and 7 in support of Defendants' "Supplemental Brief and Filing of Additional Evidence" [filed March 29, 2007], were placed into the record without the consent of Plaintiffs or their parents.

Defendants have abused their control of these sensitive records throughout this litigation. When these cases were first filed, Defendants refused Plaintiffs and their parents access to their own medical records without ever providing a rational basis for the refusal to Plaintiffs or this Court.

Now, Defendants have made these same records public in a manner that is both inappropriate and legally deficient.

IT IS ORDERED that the medical records of the minor Plaintiffs, filed by Defendants as exhibits A-H in support of Defendants' "Reply to Equitable Remedies Sought by Plaintiffs" [filed March 26, 2007] and the medical records of Plaintiffs' parents, filed by Defendants as exhibits 6 and 7 in support of Defendants' "Supplemental Brief and Filing of Additional Evidence" [filed March 29, 2007] shall be PLACED UNDER SEAL by the Clerk of this Court immediately.
