Investigation established insufficient evidence to prove or disprove the allegation of abuse as alleged in a transmittal from the Ft Jackson CID office.



BASIS FOR INVESTIGATION: On 29 Jun 04, this office received a Request For Assistance (RFA)(0068-04-CID389-80663) from the 75th Military Police (MP) Det. (CID)(-), Mosul, Iraq, who requested this office locate, fully identify, and interview Detainees [redacted] National Detainee Reporting System (NDRS) [redacted] NDRS [redacted] NDRS [redacted] NDRS [redacted] and [redacted] NDRS [redacted], in regards to possible abuse when captured by US Forces between 19 and 21 Feb 04.

About 0900, 30 Jun 04, SA [redacted] this office, obtained the Dossiers for Detainees [redacted] and [redacted] from the In-processing Section, Baghdad Central Confinement Facility (BCCF), Abu Ghraib, Iraq (AGI). (See Dossiers)

About 1000, 30 Jun 04, SA [redacted] researched the Magistrates Cell database and determined that Detainee [redacted] was released; Detainees [redacted] and [redacted] were located at Camp Bucca, and Detainees [redacted], [redacted], and [redacted] are located at BCCF, AGI.

AGENTS COMMENT: The detainee files for Detainee [redacted] and [redacted] were maintained in the files of Detainee Operations, Multi-National Corps-Iraq (MNC-I), Camp Victory, Iraq.

At 1330, 14 Jul 04, SA [redacted] conducted a search of the Biometrics Automated Toolset (BATS), which revealed there no interrogation records/reports pertaining to Detainees [redacted] and [redacted]

1345, 14 Jul 04, SA [redacted] coordinated with SSG [redacted] 391st MP BN Aid Station, BCCF, AGI. SSG [redacted] stated she did not have any of the detainees' medical files there and that they may have been transferred.

At 1400, 14 Jul 04, SA [redacted] coordinated with the Magistrates Cell, BCCF, who related Detainees [redacted] and [redacted] have been transferred to Camp Bucca.

STATUS: Your RFA has been completed in the attached enclosures. No further investigative activity was anticipated by this office.

DETAILS

BASIS FOR INVESTIGATION: About 1000, 28 Jul 04, this office received an RFA from the 75TH MP DET (CID) (FWD), Mosul, Iraq (IZ) requesting interviews of Mr. [REDACTED], NDRS # [REDACTED] and Mr. [REDACTED], NDRS # [REDACTED], detainees at Camp Bucca (CB), IZ, regarding an allegation they were both abused while being transported in the back of a vehicle after being detained in a raid.

1100, 29 Jul 04 SA [REDACTED] interviewed Mr. [REDACTED], who detailed he was asleep at his father's residence when he awoken by US Soldiers entering the residence. The US Soldier's placed him in plastic handcuffs and he was put in the back of military vehicle. Once inside of the vehicle the door closed and the soldiers blindfolded him and his brothers. The Soldiers then began to yell and punch the detainees occupying the vehicle. Mr. [REDACTED] stated after the incident he had a small cut on the left side of his ribcage.

Agent's Comment: A visual check of Mr. [REDACTED] ribcage area showed no bruising or scars. Mr. [REDACTED] also stated he cut his foot, but it occurred due to his own neglect when entering the vehicle. Mr. [REDACTED] related his last name was actually [REDACTED] that [REDACTED] was a different part of his name, but was not his last name.

1105, 29 Jul 04 SA [REDACTED] interviewed Mr. [REDACTED] NDRS # [REDACTED], who detailed he was detained on 19 Feb 04, while asleep in his home. Mr. [REDACTED] related he was blindfolded while inside of his home, was taken outside and lifted into a vehicle. Mr. [REDACTED] related he could not see anything while inside the vehicle, but he could hear well enough to hear other people breathing. Mr. [REDACTED] denied he was beaten while in the vehicle nor did he hear anyone else get beaten. See AIR for details.

AGENT'S COMMENTS: Mr. [REDACTED] related since he had been detained he had talked to all the other people detained from his neighborhood with him and none of them had indicated they had been beaten. Mr. [REDACTED] related if someone had been beaten, he would know about it. Mr. [REDACTED] also stated the correct spelling of his name was [REDACTED] /// Last Entry ///

I, [Redacted], want to make the following statement under oath:

Written by SA [Redacted], Criminal Investigation Command, Camp Arifjan, Kuwait. On 19 Feb 04, at approximately 0300 I was awoken by someone entering my father's residence. I was asleep in the bedroom. US soldiers were inside of the house then grabbed myself and my three brothers [Redacted]

We were placed in plastic handcuffs with our hands in front of me. The soldiers then put me in the back of a large vehicle that was bin folded and sandbags were put over our heads. They began to yell at us and punched us in the head and stomach areas. During the drive the soldiers hit and punched me on and off every 5 to 10 minutes. The drive lasted about half an hour. From the punching I had a small cut on the right side of my rib cage. You cannot see the cut anymore. I also cut my ankle while getting into the vehicle. The cut is on my left ankle around the inside ball of my ankle. When we arrived at Talafat Airport and the soldiers released us to another group of soldiers. There they made us stand up for long periods of time. During my stay at the airport no one punched me or hurt me. When we were at Mosul they took care of my ankle. I was treated very well there by the soldiers.

STATEMENT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:
This statement is being hand-written by Special Agent [Redacted] and translated by Interpreter [Redacted] for Mr. [Redacted]

There was an explosion far away from my home, 3-4 days later on 19 Feb 04 about 2:00 AM, Americans raided my neighborhood and arrested 16 of us. They blow open my front door and many soldiers came into my house and arrested me as I slept with my wife. The soldiers handcuffed me and blindfolded me in my house. They put a sandbag over my head and put my hands behind my back. They took me outside, two soldiers picked me up and put me in the back of a vehicle. I could not see anything but I could hear and feel other people in there with me. I was in the vehicle for about an hour until we arrived at Tal Afar west airport. There they took off my handcuffs and blindfolds, then they fed us and gave us water. There I saw my family was also there. I stayed there until 21 Feb 04. Then I was handcuffed and blindfolded again and put on the back of a large military truck with straps over the back. I was at Mosul until 9 March when I was flown to Abu Ghraib prison by helicopter. I was at Abu until 8 May 04 when we were bused to Camp Bucca. I have been here ever since.

Q. Can you describe the vehicle you were in the first day?
A. I was blindfolded and could not see anything. But it was a slower vehicle. I sat on the floor, not on a seat.

Q. How did you know there were other detainees in the vehicle with you?
A. I could feel them next to me. I could also hear them breathe and moving around. We weren't allowed to talk though.

Q. Were you beaten while you rode in this vehicle?
A. No.

Q. Was anyone else beaten in this vehicle?
A. No.

Q. If anyone else had been beaten would you have been able to hear it?
A. Yes, I could hear people breathing and moving but no one was

I entered this objective with the assaulters and we detained about five Iraqi males. SSG [redacted] SGT [redacted], and LT [redacted] were with me on this operation but I don't recall who else. None of Iraqis resisted apprehension. The Iraqis were moved to our vehicles for transport to checkpoint 101. I think most of the detainees were placed in the back of a HMMWV but one or two of them may have been placed in one of the strikers. Following the raid we drove to Checkpoint 101 where the detainees were placed in other vehicles and transported to FOB FULDA. I don't recall which element of C Co. took custody of the detainees. After the detainees were turned over, I got into the commander's vehicle and returned to Rock Base.

This ride was about 10-15 minutes long. We were taken out of the vehicle and sat on the ground. The tape was pulled so we could talk. After about an hour, we were asked for our names. After about 30 minutes more we were walked to another area where we changed out of our clothes and into an orange colored jumpsuit. We were taken to a wooden room like a cage, and our hands were tied to the walls. I found out the next day this was Talifar airport. I was at Talifar airport for 1 day and 1 night. Then I was taken to Mosul airport in a "lorrie", a big flat-bed truck, with two long benches to sit on and a canvas cover over where we sat. It was an all green military truck. I was at Mosul airport for 25 days. Then I was taken by black hawk helicopter to Abu Ghraib. I was there for over 4 months. Then I was taken by bus to Camp Bucca, where I have been until today.

It happened so fast, by the time I woke up, I couldn't move, I had an American standing over me. I'm not sure what clothing or gear they were wearing. I was handcuffed, blindfolded and my mouth taped shut while I was in the living room. I was taken to the yard with my brothers. While I was kneeling in the yard one of the soldiers kicked me in the top, center of the front of my chest and knocked me over. I was in the yard for about 5 minutes, then I was taken to a vehicle. I think it was an armored car. This armored car drove to Almekar, the old Baath Party headquarters, which was now being used as a headquarters by the Americans. I did not see it, but the vehicle went left from my house which is the direction Almekar is. This ride lasted less than 5 minutes. At Almekar we were taken out of the first armored car and placed in a second armored car, the same type I think. From there, we were driven to Talifar Airport. This ride lasted 7-10 minutes. After we had driven a little way, the soldiers started punching me in the face with their fists. They hit me 6-6 times, all over my face. I also heard my brother being hit and moaning in pain. The soldiers were hitting us and laughing at us. Once we got to Talifar Airport, we stayed there for 2 days. Then we were taken by "Lorrie" to Mosul Airport. I was at Mosul Airport for about 23 days. I was then taken by helicopter to Abu Ghraib on 18 Mar 04. On 31 Jun 04 I was brought by bus to Camp Bucca.
