This is an "Operation Iraqi Freedom" Investigation.

This investigation was initiated based on notification from the 10th Military Police
Battalion (CID), that an Iraqi prisoner died while in U.S. custody at the above location.

Further investigation established probable cause to believe Mr. SPAH died of
arteriosclerotic coronary artery disease. Significant findings of the autopsy included
severe narrowing of the blood vessels supplying blood to the heart and enlargement of the
heart. No external or internal trauma was noted.

On 20 Jan 04, this office received the autopsy examination report pertaining to Mr.
SPAH. The autopsy report showed the cause of death as arteriosclerotic cardiovascular
disease and the manner of death as natural.

This investigation was initiated based on notification from the 10th Military Police Battalion (CID), that an Iraqi prisoner died while in U.S. custody at the above location.

The investigation established probable cause to believe Mr. SPAH died of Myocardial Infarction due to extreme heat and self induced dietary restriction. Mr. SPAH was held by U.S. forces as a prisoner at the Abu Ghraib Prison. On 13 Aug 03, Mr. SPAH was brought to the gate by other detainees with no vital signs. Mr. SPAH was pronounced dead at 0548, 13 Aug 03.

DETAILS

BASIS FOR INVESTIGATION:

About 1800, 16 Aug 03, SA **b7c/b6-1** was notified by the 10th Military Police Battalion (MP Bn) (CID), Victory Camp, Baghdad, Iraq APO AE 09335, that an Iraqi National Prisoner had died while in U.S. Army custody at Abu Ghraib, Iraq.

DETAILS:

About 1150, 18 Aug 03, SA **b7c/b6-1** coordinated with SSG **b7c/b6-1**, S-3 NCOIC, 320th MP Bn, Camp Ganci, Abu Ghraib, Iraq, APO AE 09335, who provided A Serious Incident Report (SIR), for Mr. Dham SPAH, Service Number # 13915, Dossier: {2A5D1258-57B3-452B-9B9C-F1B0A1ED0F06} (NFI). (See case file for SIR)

About 1205, 18 Aug 03, SA **b7c/b6-1** coordinated with MAJ (Dr.) **b7c/b6-1**, Bn. Surgeon, 400th MP Bn., Fort Meade, MD, deployed to Iraq, who related Mr. SPAH arrived at Camp Ganci from Camp Cropper and was treated for severe dehydration. Mr. SPAH was on an eight day hunger strike and would not eat American food. At approximately 0530, 13 Aug 03, Mr. SPAH was discovered by other detainees in his detention area, to have no pulse. He was subsequently transported to the medical treatment facility at Camp Ganci. Upon arrival, Mr. SPAH had no pulse or respiration, his pupils were fixed and dilated, and he had early rigor mortis. Dr. **b7c/b6-1** further related that Mr. SPAH's probable cause of death was Myocardial Infarction due to extreme heat and self induced dietary restriction.

About 1215, 18 Aug 03, SA **b7c/b6-1** coordinated with SFC **b7c/b6-1**, Personnel Service Sergeant, 320th MP Bn, Camp Ganci, Abu Ghraib, Iraq APO AE 09335, who provided the Certificate of Death for Mr. SPAH. Mr. SHAH was pronounced dead at 0548, 13 Aug 03, by MAJ (Dr.) **b7c/b6-1**, with the cause of death listed as Myocardial Infraction. (See Attached Death Certificate and Data Sheet)
