On 4/20/2004, members of the [redacted] Team (SSA [redacted], SSA [redacted], SA [redacted] and IA [redacted] arrived back in Baghdad to join Language Specialist (LS) [redacted]. SA [redacted] replaces SSA [redacted] who apparently left Baghdad prior to the team's return.

Since their return, the team has been busy with a myriad of administrative matters including obtaining necessary orientation and security badges for SA [redacted] and locating/reorganizing files that were moved during the team's absence. Tomorrow, the team will be relocating to a new, secure space provided by [redacted] and directly adjacent to their facility.

In addition, the team has been busy re-establishing liaison with officials at the [redacted] Iraqi Survey Group (ISG) and Camp Cropper (where [redacted] is currently housed) some of whom apparently misinterpreted SSA [redacted] departure as indication that the [redacted] Team was not returning.

In any event, the [redacted] Team briefed a new crew of military police (MP's) who will be guarding [redacted]. The MPs were told of their valuable role in keeping the interview team apprised of significant matters regarding their interactions with and observations of [redacted] in addition, they were provided with instruction on cultural sensitivity and provided with guidance on how to handle particular matters as they may arise with [redacted].

In the interim, SSA [redacted] is continuing his daily informal contacts with [redacted] at the latter's daily medical check-ups.
